



"1200MOX" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you:
 - (a) during the Promotion Period, use an Invitation Code to open a Mox Account;
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process and receive a welcome notification from Mox (the day on which you receive the welcome notification, your "Joining Day"); and
 - (c) during the period beginning on and from the day you use the Invitation Code and the following 30 days, complete the Mox Credit application process and receive a Mox Credit approval notification from Mox,

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其所有附表),其分別可於 Mox app 及/或我們的網站上找到及我們可能 向您提供的任何其他條款而該等條款將繼 續一併適用於您與我們的關係及您就我們 的產品及服務的使用。
- 3. 如本條款與我們任何其他的條款有任何不一致, 概以本條款為準。
- 4. 除非本條款另有定義或另有所指,否則本條款中使用的定義與我們一般條款及細則的定義含義相同。

- 6. If you, during the period beginning on and from your Joining Day and the following 60 days, spend at least HKD2,000 on one or more Eligible Transaction(s) with your Mox Card ("Spending Requirement"), subject to these terms, you will receive the Spending Reward, which we will deposit into your Mox Account within 45 days following settlement of the last Eligible Transaction to contribute towards the satisfaction of the Spending Requirement.
- 7. You can only participate in the Promotion once. You can only receive one Welcome Reward and one Spending Reward.
- 8. We will determine whether an Eligible Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).
- 9. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
 - (a) you have not held a Mox Account in your name, at any time, in the 12 months prior to your Joining Day. You are considered to have held a Mox Account even if you haven't completed any transactions on your previous Mox Account:
 - (b) when we attempt to deliver the reward, gift or other benefit, you still have your Mox Account that you opened using the Invitation Code and Mox Credit that you opened pursuant to the Promotion and none of your accounts with Mox have been suspended or is in arrears or default; and

- 10. We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in these terms or any reward, gift or other benefit in respect of the Promotion and/or its monetary value);
 - (b) suspend or terminate the Promotion or these terms:
 - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
 - (i) if we believe any of your accounts with Mox has been opened for an improper purpose (for example, to secure multiple rewards, gifts or other benefits by closing and opening one or more Mox Accounts);
 - (ii) if we believe that any proceeds in any of your accounts with Mox are the proceeds of any illegal, fraudulent or abnormal activity; or
 - (iii) for any other reason we deem appropriate; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

- 19. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 20. A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties)

- 21. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 22. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.
- 23. To borrow or not to borrow? Borrow only if you can repay!

24. Definitions

The following capitalised terms have the meanings set out below:

- (a) "Eligible Transaction(s)" means transactions for the purchase of goods or services, as we determine, from time to time, to be eligible to contribute towards a Spending Requirement. Without limiting the above:
 - (i) for a transaction to contribute towards a Spending Requirement, the transaction must have been settled by the merchant (i.e. appear as 'completed' in the Mox app) by the end of the period specified in clause 6 of these terms; and
 - (ii) transactions that are ineligible for Mox Card Rewards are not Eligible Transaction(s) (see clause 2 of the Rewards for Cards Schedule for transactions that are ineligible for Mox Card Rewards, which include e-wallet top-ups such as Octopus top-ups conducted using Apple Pay).
- (b) "Invitation Code" means either:

- (e) "Spending Requirement" has the meaning given in clause 6 of these terms.
- (f) "**Spending Reward**" means a cash reward of HKD1,000.
- (g) "Welcome Reward" means a cash reward of HKD200.
