

Top Up Instant Loan: Early Repayment Fee Refund Promotion (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“Mox”, “we”, “us” or “our”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
3. Unless defined in these terms or the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
4. If:
 - (a) during the Promotion Period, you apply for a top up of your existing Instant Loan(s) in the Mox app (“**Top Up Application**”); and
 - (b) your Top Up Application is approved by us on or before 15 January 2027,
 subject to these terms, we will refund any early repayment fee we have charged in respect of the early closure of your existing Instant Loan(s) as part of your Top Up Application (“**Refund**”), which we will deposit into your Mox Account on or before 28 February 2027.
5. The number of Refunds we will provide under the Promotion is subject to a quota of 5,000 Refunds (“**Quota**”). We will

1. 本條款適用於 Mox Bank Limited（「Mox」或「我們」）進行的本推廣。參與本推廣即表示你同意接受本條款。
