Please note that such an option is a direct arrangement offered by the overseas merchant and not Mox. You should ask the overseas merchant for details about the foreign currency exchange rate and any applicable fees before you enter into the transaction because settling foreign currency transactions in Hong Kong dollars may involve fees imposed by the merchant in addition to the cross-border access fee (and may involve a cost higher than the foreign exchange handling fee – see above).

A Mox Credit fund transfer includes a payment (including an automatic payment and other recurring arrangement) using Mox Credit on the Mox app to another Mox user or any other non-Mox Hong Kong bank account or other FPS "Participants" (as defined in Part B of Schedule 2 to the General Terms and Conditions). Please note that the applicable handing fee and/or monthly threshold may depend on prevailing promotional terms and conditions.
	When you request to make a Mox Credit fund transfer that will exceed the applicable monthly threshold, you will be prompted in the Mox app to acknowledge the applicable handling fee. When you set up an automatic payment or other recurring arrangement that is a Mox Credit fund transfer, you will be
