



Mox Card Rewards Table

This document sets out details of the Mox Card Rewards available for eligible transactions on your Mox Card. Please read this document together with the Rewards for Cards Schedule.

This document replaces any previous documents, tables or information we have published in respect of Mox Card Rewards (including CashBack).

We may change the information in this document from time to time without giving you prior notice. We may also specify, change, modify, suspend, terminate or make any decision in connection with any Mox Card Rewards at any time without giving you prior notice.

Unless the context requires otherwise, capitalised terms used in this document shall have the meanings given in our General Terms and Conditions. If there is any inconsistency or conflict between the English and Chinese versions, the English version shall prevail.

1. CashBack for Mox Card linked to Mox Account

If you make eligible transactions on your Mox Card linked to your Mox Account, this section 1 will apply to you.
