



Mox Split Purchase Lucky Draw Promotion (March – May 2025) ("Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.

5. If:

- (a) you, during the Entry Period, apply for a Split Purchase of any tenor for one or more eligible Mox Credit transaction(s) or Eligible Statement Balance with a total principal amount of at least HKD5,000; and
- (b) such Split Purchase is approved by us on or before 18 May 2025 (an "Eligible Split Purchase"),

subject to these terms, you will receive one entry into the Lucky Draw for each Eligible Split Purchase that is approved pursuant to the Promotion.

 We will determine whether a Split Purchase is an Eligible Split Purchase based on the records held by us, which are final and conclusive in case of any discrepancy.

Mox 簽賬分期大抽獎推廣 (「本推廣」) (2025年3月至5月) 條款及細則

- 1. 本條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」)進行的本推廣。 參與本推廣即表示您同意本條款。

- If you receive an entry into the Lucky Draw, we will automatically enter you into the draw without any further action from you.
- 8. We will hold the Lucky Draw on 5 June 2025 and select 10 winners randomly (each, a "Winner"). We will notify each Winner on or before 19 June 2025. If you are a Winner, we will send you an email and SMS letting you know that you have won. We will send such email and SMS to your email address and phone number, based on our records. We will also announce the Winners of the Lucky Draw on our website and/or social media platforms on or before 19 June 2025.
- If you are a Winner, subject to these terms, you will receive the Reward. The Reward will be deposited into your Mox Account on or before 30 June 2025.
- The number of times you can enter into the Lucky Draw is unlimited. However, you can only receive one Reward.
- 11. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
 - (a) you hold a valid Mox Account and Mox Credit in your name when we attempt to give you the reward, gift or other benefit, and none of your account(s) with Mox having been suspended or closed by you or us or in arrears or default;
 - (b) the relevant Eligible Split Purchase has not been cancelled; and
 - (c) you satisfy any additional requirements we may specify from time to time.
- 12. We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in these terms or any reward, gift or

The following capitalised terms have the meanings set out below:

- (b) "Entry Period" means the period beginning on 10 March 2025 and ending on 17 May 2025 (both dates inclusive).
- (c) "Lucky Draw" means the lucky draw operated by Mox for a chance to win the Reward.
- (d) "Reward" means HKD10,000.
