

Add Money Promotion (February-April 2026) (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
5. If you:
 - (a) are invited to register for the Promotion in the Mox app (we reserve the right to select and invite customers to participate in the Promotion in our sole and absolute discretion);
 - (b) during the Registration Period, register for the Promotion in the Mox app; and
 - (c) use the ‘Add money’ feature in the Mox app to deposit at least HKD25,000 into your Mox Account in one or more transactions in a calendar month during the Promotion Period (you will have successfully added money if you receive a notification from Mox that you have added money to your Mox Account),
 subject to these terms, you will receive one Reward for that calendar month.

「入錢」推廣(2026年2-4月) (「本推廣」) 條款及細則

1. 本條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」) 進行的本推廣。參與本推廣即表示您同意本條款。
2. 您必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策聲明、一般條款及細則 (包括其所有附表), 其分別可於 Mox 應用程式及 / 或我們的網站找到, 及我們可能向您提供的任何其他條款, 而該等條款將繼續一併適用於您與我們的關係及您就我們的產品及服務的使用。
3. 如本條款與我們任何其他的條款有任何不一致, 概以本條款為準。

For avoidance of doubt:</p> <p>(a) deposits made through transfer methods other than the 'Add money' feature in the Mox app, will not count towards the satisfaction of the requirements set out in clause 5(c) of these terms; and</p> <p>(b) only deposits you make in Hong Kong dollars using the 'Add money' feature will count towards the satisfaction of the requirements set out in clause 5(c) of these terms.</p> <p>7. You can only participate in the Promotion once in each calendar month during the Promotion Period. You can only receive one Reward for each calendar month during the Promotion Period.</p> <p>8. Registration for the Promotion is subject to a quota of 2,000 registrations. The 'Registration Period' will end on the earlier of (a) the last day of that period, and (b) the day on which there has been 2,000 registrations. Registration for the Promotion is on a first come, first served basis (as determined by us in our absolute discretion).
