



Asia Miles Stamp Card Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. Without limiting clause 2 of these terms, these terms must also be read together with the CX Registration Terms.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 6. During the Promotion Period, if you:
 - (a) register for the Promotion in the Mox app;
 - (b) make one or more Eligible Transaction(s); and
 - (c) at the time you make the Eligible Transaction, ensure that you have chosen the Spending Rewards Scheme for 'Asia Miles' in the Mox app,

subject to these terms, you will receive the "Reward(s)" corresponding to the number of Eligible Transaction(s) you have made (on a cumulative basis), as set out in the table below:

- 1. 本條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」)進行的本推廣。 參與本推廣即表示您同意本條款。

Each Reward will be delivered to your Cathay Membership Account upon settlement of the last Eligible Transaction that you have made to complete the number of Eligible Transactions to entitle to the relevant Reward

For example, during the Promotion Period, if you complete 15 Eligible Transactions, you will receive a total 8,250 Asia Miles. You will receive 250 Asia Miles upon the settlement of your first Eligible Transaction, 1,000 Asia Miles upon the settlement of your fifth Eligible Transaction etc..

- 7. After the completion of each Eligible Transaction, you will receive a 'stamp' on the Promotion page in the 'Mox Rewards' page of the Mox app. The page will show the total number of Eligible Transactions that you have completed.
- 8. If you are eligible to receive Asia Miles pursuant to the Promotion, we will let AML know using your Membership Information, so that AML can deliver the Asia Miles to your Cathay Membership Account. We are not responsible for the delivery of any Asia Miles to your Cathay Membership Account and will not be liable for any failure or delay in the delivery of any Asia Miles to your Cathay Membership Account.
- 9. From time to time, we may require you to provide additional information in connection with your Cathay Membership

Account to maintain its registration with Mox and/or to facilitate the delivery of any Asia Miles you may be eligible to receive pursuant to the Promotion. We will notify you of any such requirements from time to time

- 10. It is your responsibility to ensure the accuracy and completeness of the information that you provide to us. If any information that you provide to us (including any Membership Information) is inaccurate and/or incomplete, we may not be able to register your Cathay Membership Account with us, you may not be eligible to receive any Asia Miles pursuant to the Promotion and/or the Asia Miles may not be delivered to your Cathay Membership Account.
- 11. You can only participate in the Promotion once. You can only receive each type of Reward once.
- 12. We will determine whether an Eligible Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).
- 13. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
 - (a) you hold a valid Mox Account and Mox Credit in your name when we attempt to give you the reward, gift or other benefit, with that Mox Account and Mox Credit not having been suspended or closed by you or us or in arrears or default; and
 - (b) you hold a valid Cathay Membership Account in your name which you have registered with Mox in accordance with the CX Registration Terms; and
 - (c) you satisfy any additional requirements we may specify from time to time.
- 14. We reserve the right, at any time, without

- (b) suspend or terminate the Promotion or these terms;
- (c) refuse to give you any reward, gift or other benefit in respect of the Promotion for any reason we deem appropriate; and
- (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

- 15. Without limiting anything in these terms, we may determine whether or not you can combine the Promotion with other offers or promotions that we may offer from time to time. We will let you know if you can combine the Promotion with other offers or promotions in the Mox app and/or our website or through any other communication channels we may determine from time to time.
- 16. If you have received any Asia Miles in respect of the Promotion, and any of the transaction(s) which resulted in you receiving those Asia Miles is subsequently reversed, cancelled or refunded subsequently (in full or in part), at any time, we reserve the right to deduct HKD0.10 for each Asia Mile you received for that transaction or the Promotion (or the relevant part of that transaction or the Promotion) from your Mox Account.
- 17. If any dispute arises in connection with the Promotion, our decision is final.

- 18. To the extent permitted by laws and regulations:
 - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and
 - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox or its affiliates, shareholders or partners,

arising from or in connection with your participation in the Promotion (including any decision not to give you, or your failure to receive any reward, gift or other benefit) or these terms, unless:

- (x) any such loss, damages, action, proceeding or claim is due to; and
- (y) where such loss, damages, action, proceeding or claim was reasonably foreseeable and has arisen directly and solely from,

Mox's or its affiliates', shareholders' or partners' negligence, fraud or wilful default.

This clause 18 continues after the expiry or termination of the Promotion or these terms.

19. You acknowledge that third parties (including our indirect direct or shareholders) may provide us with payments (such as subsidies) or other benefits or advantages in connection with the Promotion. The nature, amount and method of calculating any such benefit or advantage may vary from time to time. We are entitled to retain any such benefit or advantage for our own account and benefit, absolutely, without having to make any prior disclosure to you.

- (x) 因 Mox、其關聯公司、股東或合作夥 伴的疏忽、欺詐行為或故意失責而引 致; 及
- (y) 合理可預見的及直接及完全由該等疏 忽、欺詐行為或故意失責而引致。

本第 18 條在本推廣或本條款到期或終止後繼續有效。

- 20. You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) or other benefits or advantages from us directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any such benefit or advantage may vary at any time and such third parties are entitled to retain any such benefit or advantage for its own account and benefit absolutely without having to make any prior disclosure to you.
- 21. The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 22. Neither your right to participate in the Promotion nor your eligibility to receive any reward, gift or other benefit in respect of the Promotion may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 23. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 24. The Asia Miles awarded under the Promotion is supplied by AML. We are not the supplier of any Asia Miles. The Mox Disclaimer applies in respect of any Asia Miles awarded under the Promotion.
- 25. The Cathay Membership Programme (including your Cathay Membership Account) and Asia Miles (including your use of any Asia Miles) are subject to terms and conditions issued by AML.
- 26. If you have any questions regarding:
 - (a) the Promotion, please contact our Customer Care Team; and
 - (b) the Cathay Membership Programme and Asia Miles, please contact Cathay Pacific Airways Limited's customer

- 27. A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.
- 28. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 29. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.
- 30. To borrow or not to borrow? Borrow only if you can repay!

31. Definitions

The following capitalised terms have the meanings set out below:

(a) "Eligible Transaction" means a transaction for the purchase of goods or services (as determined by us, in our sole and absolute discretion, from time to time), made with your Mox Credit Card with a value of HKD1,000 or more.

Without limiting the above:

- (i) for the transaction to be an 'Eligible Transaction', the transaction must have been settled by the merchant (i.e. appear as 'completed' in the Mox app) on or before 16 February 2025; and
- (ii) transactions that are ineligible for Mox Card Rewards are not Eligible Transaction(s) (see clause 2 of Rewards for Cards Schedule for

31. 定義

以下定義於本條款内具有以下的含義:

- (b) "Mox Credit Card" means Mox Card with credit.
- (c) "Promotion Period" means the period beginning on 12 December 2024 and ending on 16 February 2025 (both dates inclusive).
- (d) "Reward" has the meaning given in clause 6 of these terms.
