



Bonus rate promotion (November 2025) (the "Promotion") terms and conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. You will receive additional daily interest on all your USD Eligible Savings Deposits and up to HKD1,000,000 of your HKD Eligible Savings Deposits calculated at the applicable Bonus Rate(s) ("Additional Interest"), if (and subject to these terms) during the Promotion Period, you:
 - **(a)** Complete through Mox one or more of the following transactions:
 - (i) net purchase of Fund unit(s) that is not an exchange traded fund (a "Net Fund Transaction"); and/or
 - (ii) exchange currency(ies) to another currency(ies) (an "FX Transaction"); and
 - (b) those transaction(s) have Transaction Amounts that total (the "Cumulative Amount") at least the Interest Unlock

額外年利率活動 (2025 年 11 月) (「本推 廣」) 條款及細則

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)提供的本推 廣。參與本推廣即表示您同意接受本條 款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策聲明、一般條款及細則(包括其附表),其分別可於Mox app 及/或我們的網站上找到及我們可能向您提供的任何其他條款。除本條款外,任何前述條款亦繼續一併適用於您與我們的關係及您就我們的產品及服務的使用。
- 3. 本條款與我們任何其他的條款如有任何 不一致,概以本條款為準。
- 4. 除非另有定義或另有所指,本條款中使 用的定義與我們一般條款及細則的定義 相同。
- 5. 受制於本條款,如您在推廣期內:
 - (a) 經 Mox 完成以下一個或多個交易:

The above is referred to as the "Bonus Rate Requirement".

For the avoidance of doubt, you will not receive any Additional Interest for deposits held in your Time Deposit Account(s) and (if applicable) FlexiBoost Account(s).

- The Additional Interest will be calculated on a 365-day year basis for HKD Eligible Savings Deposit and 360-day year basis for USD Eligible Savings Deposit.
- 7. The "Transaction Amount" means:
 - (a) for a Net Fund Transaction, the total 'investment amount' in Hong Kong dollars in respect of all purchase orders of unit(s) in Funds that you have successfully submitted minus the total amount in Hong Kong dollars in respect of all sell orders of unit(s) in Funds that you have successfully submitted (you will have 'successfully' submitted the order when you arrive at the screen on your Mox app stating that you have successfully placed order), but excluding:
 - (i) the total amount in respect of all the buy orders and sell orders of the underlying Funds in a portfolio of Funds as a result of Rebalancing; and
 - (ii) any applicable fees and charges, and
 - (b) for an FX Transaction, the amount of currency that is sold (inclusive of any applicable fees and charges) in Hong Kong dollars,

to the extent that the amount of currency sold in an FX Transaction or the 'investment amount' in a Net Fund Transaction is denominated in any currency(ies) other than Hong Kong dollars, the relevant amount(s) 合資格活期存款按適用的額外年利率每日計算的額外利息(「**額外利息**」)。

- 8. Without limiting anything in clause 7 of these terms, in respect of a Net Fund Transaction(s):
 - (a) purchases or sales of unit(s) in a single fund product or underlying Funds in a portfolio of Funds that are otherwise not purchases or sales as a result of Rebalancing will be included in the calculation of the Cumulative Amount:
 - (b) to the extent that the Transaction Amount is negative, the Transaction Amount will be deemed to be HKD0 in respect of its contribution to the Cumulative Amount; and
 - (c) for any order that is successfully submitted during the Promotion Period and is passed onto the execution broker(s) on a later date (as shown in the 'Order Placement Date' in the 'Activity details' on your Mox app), the Transaction Amount of the order will be deemed to be contributing to the Cumulative Amount of the day on which your order is successfully submitted.
- 9. We will determine whether you have met the Bonus Rate Requirement as of 23:59:59 (Hong Kong time) on each calendar day during the Promotion Period (but excluding the last calendar day). Our determination will be based on the records held by us, which are final and conclusive.
- 10. If you have met the Bonus Rate Requirement on a calendar day during the Promotion Period (excluding the last calendar day) ("Completion Day"), the Bonus Rate will be applied on your Eligible Savings Deposit as at 23:59:59 (Hong Kong time) on the day following the Completion Day.

- 11. We will credit any Additional Interest into any one of your savings accounts with Mox in the currency(ies) that the Additional Interest is denominated within two calendar days after the Completion Day together with the interest that you would have received at the base rate if you had not met the Bonus Rate Requirement.
- 12. If you have met the Bonus Rate Requirement on a calendar day during the Promotion Period (excluding the last calendar day), you must re-meet the Bonus Rate Requirement in any later Promotion Period to receive Additional Interest for that later Promotion Period. For clarity, it is not possible to meet the Bonus Rate Requirement on the last calendar day of the Promotion Period in order to receive Additional Interest.
- 13. You will only receive the Additional Interest if:
 - (a) you hold a valid Mox Account in your name when we attempt to credit the Additional Interest;
 - **(b)** none of your accounts with Mox have been suspended or closed by you or us or are in arrears or default; and
 - **(c)** you satisfy any additional requirements we may specify from time to time.
- 14. If you have received Additional Interest and any of Net Fund Transactions is subsequently reversed or cancelled (including for reasons beyond your control) so that the Bonus Rate Requirement is no longer met, we reserve the right to deduct the relevant Additional Interest amount from any of your account(s) with Mox.
- 15. We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in

- (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:

 - (ii) for any other reason we deem appropriate; and
- (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other promotion).

Any such decision shall be conclusive and binding on you.

- 16. Without limiting anything in these terms, we may determine whether or not you can combine the Promotion with other offers or promotions that we may offer from time to time. We will let you know if you can combine the Promotion with other offers or promotions in the Mox app and/or our website or through any other communication channels we may determine from time to time.
- 17. If any dispute arises in connection with the Promotion, our decision is final.

- 18. To the extent permitted by laws and regulations:
 - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and
 - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox or its affiliates or shareholders or partners,

arising from or in connection with your participation in the Promotion (including any decision not to give you, or your failure to receive any reward, gift or other benefit) or these terms, unless:

- (c) any such loss, damages, action, proceeding or claim is due to; and
- (d) such loss, damages, action, proceeding or claim was reasonably foreseeable and has arisen directly and solely from.

Mox's or its affiliates', shareholders' or partners' negligence, fraud or wilful default.

This clause 18 continues after the expiration or termination of these terms or the Promotion.

- 19. You acknowledge that third parties (including our direct or indirect shareholders) may provide us with payments (such as subsidies) and other benefits or advantages in connection with the Promotion. The nature, amount and method of calculating any such benefits or advantages may vary from time to time. We are entitled to retain any such benefits or advantages for our own account and benefit, absolutely, without having to make any prior disclosure to you.
- 20. You acknowledge that third parties may receive payments (such as remuneration,

- 23. A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623) other than as set out in these terms.
- 24. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 25. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

26. Definitions

The following capitalised terms have the meanings set out below:

(a) "Additional Interest" has the meaning given in clause 5 of these terms.

- (ii) in respect of USD Eligible Savings Deposit of any amount, 2.75% p.a.

For example, if you meet the Bonus Rate Requirement on 3 November 2025 and maintain Eligible Savings Deposits of HKD6,000,000 and USD8,000,000 on 4 November 2025, you will receive Additional Interest on HKD1,000,000 and USD8,000,000 calculated at the following Bonus Rates on 5 October 2025:

- (iii) HKD1,000,000 of 1.999% p.a.; and
- (iv) USD8,000,000 at 2.75% p.a.
- **(c)** "Bonus Rate Requirement" has the meaning given in clause 5 of these terms.
- (d) "Complete" means, whichever is applicable, you:
 - (i) arrive at the screen on your Mox app stating that you have successfully placed order to purchase unit(s) in a Fund that is not an exchange traded fund; and/or
 - (ii) arrive at the screen on your Mox app stating that you have successfully exchanged a currency in one of your account(s) in Mox to another currency or if applicable, your remittance order has been confirmed.
- **(e)** "Completion Day" has the meaning given in clause 10 of these terms.
- **(f)** "Cumulative Amount" has the meaning given in clause 5(b) of these terms.

- (g) "Eligible Savings Deposits" means in respect of the eligible currency, the deposits in that currency held by you in all your savings account with Mox, excluding deposits held in your Time Deposit Account(s), (if applicable) FlexiBoost Account(s) and all 'cash on hold' in your Mox Invest Account originating from unsettled proceeds from the sale of Funds or Securities.
- (h) "FX Transaction" has the meaning given in clause 5(a)(ii) of these terms.
- (i) "HKD Eligible Savings Deposits" means Hong Kong dollars denominated Eligible Savings Deposits.
- (j) "Interest Unlock Amount" means, in respect of meeting the Bonus Rate Requirement, the minimum Cumulative Amount that you need to achieve as displayed in your Mox app.
- **(k)** "Net Fund Transaction" has the meaning given in clause 5(a)(i) of these terms.
- (I) "Promotion Period" means the period beginning on 1 November 2025 and ending on 30 November 2025 (both dates inclusive).
- (m) "Transaction Amount" has the meaning given in clause 7 of these terms.
- (n) "US Eligible Savings Deposits" means United States dollar denominated Eligible Savings Deposits.
