



"FLYWITHMOX" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. Without limiting clause 2 of these terms, these terms must also be read together with the CX Registration Terms.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 6. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Mox Account;
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process and receive a welcome notification from Mox (the day on which you receive the welcome notification, your "Joining Day"); and
 - (c) during the period beginning on and from your Joining Day and the following 30 days, complete the Mox Credit application process and receive a Mox

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。

- (y) you will receive Mox Card Rewards for the Spending Rewards Scheme you have chosen, as if you have an Eligible Balance for Card Rewards of HKD250,000 (even if you have an Eligible Balance for Card Rewards of less than HKD250,000); and
- (z) if you spend with your Mox Credit Card on one or more Eligible Transaction(s), and the total transaction amount is not less than:

- 10. From time to time, we may require you to provide additional information in connection with your Cathay Membership Account to maintain its registration with Mox and/or to facilitate the delivery of any Asia Miles you may be eligible to receive under these terms. We will notify you of any such requirements from time to time.
- 11. It is your responsibility to ensure the accuracy and completeness of the information that you provide to us. If any information that you provide to us (including any Membership Information) is inaccurate and/or incomplete, we may not be able to register your Cathay Membership Account with us, you may not be eligible to receive any Asia Miles under these terms and/or the Asia Miles may not be delivered to your Cathay Membership Account.
- 12. You can only participate in the Promotion once. You can only receive one First Spending Reward, one Second Spending

- (e) "First Spending Reward" means 15,000 Asia Miles.
- (f) "Invitation Code" means 'FLYWITHMOX'.
- (g) "Joining Day" means the day on which you receive your welcome notification, as described in clause 6(b) of these terms.
- (h) "Promotion Period" means, subject to clause 13 of these terms, the period beginning on 1 August 2025 and ending on 3 September 2025 (both
