

**Mox FlexiBoost Lucky Draw Promotion
(August – September 2025) (“Promotion”)
Terms and Conditions**

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), Mox FlexiBoost 1.0 Promotion Terms and Conditions each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
5. If:
 - (a) you, during an Entry Period, set up a FlexiBoost Account with a FB Starting Balance of at least HKD100,000 or equivalent in USD,
 - (b) such FlexiBoost Account balance is held until the last day of the Entry Period,
 - (c) you, have registered your eligible Referral Code on the lucky draw website

(such FlexiBoost Account, an “**Eligible FlexiBoost Account**”), subject to these terms, you will receive one entry into the Lucky Draw.
6. We will determine whether a FlexiBoost Account transaction is an Eligible

1. 本條款適用於由 Mox Bank Limited（「**Mox**」或「**我們**」）進行的本推廣。參與本推廣即表示您同意本條款。
