



## Instant Loan Cash Reward Promotion (the "Promotion") - Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy, General Terms and Conditions and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3. Unless the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
- 4. The Promotion runs from 2 March 2023 until 17 April 2023, both dates inclusive (the "Promotion Period"). (With effect from 17 April 2023, the Promotion Period has been extended until 30 April 2023). We may change the dates of the Promotion Period at any time in our absolute discretion.
- 5. To be eligible to participate in the Promotion, you must be one of our first 5,000 customers who apply for an Instant Loan on Mox Credit, of an amount and with a repayment period which falls within one of the two "Options" as displayed in the table in clause 20 of these terms, during the Promotion Period (an "Eligible Instant Loan").

Please note: we will not update you on whether the 5,000 quota of the Promotion has been reached.

6. If your application for an Eligible Instant Loan is approved by us on or before 1 May 2023 (a "Successful Instant Loan"), you will be eligible to receive the cash reward ("Reward") corresponding to the

- 1. 本條款適用於 Mox Bank Limited (「**Mox**」、「**我們**」)進行的推廣。參 與本推廣即表示你同意接受本條款。
- 2. 你必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策、一般條款及細則, 以及我們可能向你提供的任何其他條款。 除本條款外,任何該等條款亦一併適用, 而你就使用任何我們的產品及服務仍須受 該等其他條款的約束。本條款與我們任何 其他的條款如有任何不一致,概以本條款 為準。
- 3. 除非本條款另有所指,否則本條款中使用 的定義與我們一般條款及細則的定義含義 相同。

Instant Loan applications are ultimately determined by Mox in its absolute discretion based on Instant Loan application records held by Mox (which are final and conclusive in case of any discrepancy).

- Mox will credit the Reward to your Mox Account on or before 31 May 2023. Mox retains the discretion as to whether to credit the Reward to your Mox Account.
- 8. You can only participate in the Promotion once. You can only receive the Reward once. During the Promotion Period, if you have been selected by Mox and received an invitation email or push notification by Mox inviting you to participate in another Instant Loan promotion, your participation in such promotion cannot be combined with the Promotion.
- Neither your participation in the Promotion nor your eligibility to receive the Reward may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.

  - (c) you meet any additional requirements communicated by Mox.
- 11. Mox reserves the right at any time, without notice or reason and in its sole discretion, to:

  - (a) Mox and, its affiliates and shareholders shall not be responsible for any loss, action, proceedings or claim suffered by you; and
  - (b) you shall release Mox and, its affiliates and shareholders from all actions, proceedings and claims which may be brought by or against Mox or, its affiliates or shareholders,

arising from or in connection with your participation in the Promotion (including any decision not to offer or distribute to you, or your failure to receive, the Reward) or these terms, unless any such loss, action, proceeding or claim is due to Mox's or, its affiliates' or shareholders' negligence, fraud or wilful default and only to the extent such loss, action, proceedings or claim is reasonably foreseeable and has arisen directly and solely from such negligence, fraud or wilful default.

- 15. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as an agent or representative of Mox or otherwise soliciting business on behalf of Mox.
- 16. A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of their provisions under the Contracts (Rights of Third Parties) Ordinance (Cap. 623) other than as set out in these terms.
- 17. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 18. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.
