

<p>Langham Place Scratch Card Promotion (the “Promotion”) Terms and Conditions</p> <ol style="list-style-type: none"> 1. These terms apply to the Promotion offered by Mox Bank Limited (“Mox”, “we”, “us”). By participating in the Promotion, you agree to these terms. 2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms. If there is any inconsistency between these terms and any of our other terms, these terms will prevail. 3. Unless the context otherwise requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions. 4. During the Promotion Period, you can receive one Mox Scratch Card after each time you make an Eligible Transaction (as described in clause 5 of these terms). 5. An “Eligible Transaction” is a single transaction for the purchase of goods or services at physical stores with a value of at least HKD250 made with your Mox Credit, as determined by Mox in our absolute discretion. Each time you have satisfied the requirements in clause 4 of these terms, you will receive one digital scratch card in your Mox app ("Mox Scratch Card") containing a single cash reward ranging from HKD3 to HKD1,000 (the "Reward") that you can reveal by 'scratching' the Mox Scratch Card in your Mox app. You must 'scratch' your Mox Scratch Card on or before the last day of the Redemption Period.</p> <p>7. Subject to clause 11 of these terms, you will receive your Reward in your Mox Account once:</p> <p>(a) you have scratched the Mox Scratch Card; and</p> <p>(b) the Eligible Transaction, for which you received the Mox Scratch Card, is settled by the merchant (i.e. appear as 'completed' in the Mox app).</p> <p>8.
