

**“MHMOX” Invitation Code Promotion (the “Promotion”) Terms and Conditions**

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of our products and services remain subject to such other terms. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
3. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
4. To participate in the Promotion, you must:
  - (a) during the Promotion Period, download the Mox app and open a Mox Account using the Invitation Code;
  - (b) during the period from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process so that your Mox Account is ready for use; and
  - (c) during the period from when your Mox Account is ready for use and the following 14 days, apply and be approved for an Instant Loan on Mox Credit with an amount of HKD100,000 or more and a tenor of 24 months or more (“**Successful Instant Loan**”).
5. If you’ve completed the steps in clause 4 of these terms, then, subject to clause 6 of these terms, you will receive the Reward, which we will deposit into your Mox Account on or before 30 June 2023.
6. You can only participate in the Promotion

**「MHMOX」邀請碼推廣（「推廣」）條款及細則**

1. 本條款適用於由 Mox Bank Limited（「**Mox**」、「**我們**」）所提供的推廣。參加本推廣，即表示你同意本條款。
2. 你必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策、一般條款及細則（可參閱 Mox 應用程式及/或我們的網站），以及我們可能向你提供的任何其他條款。除本條款外，任何該等條款亦一併適用，而你就使用我們的產品及服務仍須受該等其他條款的約束。本條款與我們任何其他的條款如有任何不一致，概以本條款為準。

You acknowledge that third parties may receive remuneration, commission, rebates or other payments or benefits (together "**Benefits**") from us directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any such Benefit may vary at any time and such third parties are entitled to retain any such Benefit for their own account and benefit absolutely without having to make any prior disclosure to you.
