

“MOXBILL25” Invitation Code Promotion (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion operated by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
3. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
4. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Mox Account;
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have ‘completed’ the Mox Account opening process once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your “**Joining Day**”)); and
 - (c) during the period beginning on and from the day you use the Invitation Code and the following 30 days, complete the Mox Credit Card application journey (you will have ‘completed’ the Mox Credit Card application journey once you have received a notification from Mox letting you know that your Mox Credit Card application has been either approved or rejected or that you need to provide further information),
