



"MOXHALO2" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Moxx Account:
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have 'completed' the Mox Account opening process once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your "Joining Day"));
 - (c) during the period beginning on and from the day you use the Invitation Code and the following 30 days, complete the Mox Credit application process (you will have 'completed' the Mox Credit application process once you have received a Mox Credit approval notification from Mox (the day

- 1. 本條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」)進行的本推廣。 參與本推廣即表示你同意本條款。

(d) during the period beginning on and from your Approval Day and the following 60 days, spend at least HKD15,000 on one or more Eligible Transaction(s) with Mox Credit ("Spending Requirement"),

subject to the above terms, you will receive the Reward. which will be delivered to your email that is in our records by 31 August 2025.

- 6. You can only participate in the Promotion once. You can only receive one Reward.
- 7. The use of the Invitation Code is subject to a quota of 2,000 uses. The 'Promotion Period' will end on the earlier of: (a) the last day of that period, and (b) the day on which the Invitation Code has been used 2,000 times. The use of the Invitation Code is on a first come, first served basis (as determined by us in our absolute discretion). We will not update you on the quota usage or its continued availability.
- 8. We will determine whether an Eligible Transaction has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).
- You will receive the reward, gift or any other benefit in respect of the Promotion, only if:

 - (i) if we believe your Mox Account has been opened for an improper purpose (for example, to secure multiple rewards, gifts or other benefits by closing and opening one or more Mox Accounts); or
 - (ii) for any other reason we deem appropriate; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

This clause 14 continues after the expiry or termination of the Promotion or these terms.

 - (ii) transactions that are ineligible for Mox Card Rewards are not Eligible Transaction(s) (see clause 2(b) of the Rewards for Cards Schedule to the General Terms and Conditions for transactions that are ineligible
