



## "MOXMSCASH" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. To participate in the Promotion, you must:
  - (a) during the Promotion Period, use the Invitation Code to open a Mox Account; and
  - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have 'completed' the Mox Account opening process once you have received a welcome notification from Mox).
- 6. If you satisfy the requirements in clause 5 of these terms, and you:
  - (a) during the period beginning on and from the day you use the Invitation Code and the following 30 days, complete the Mox Credit application

- (e) "HKD Savings Account Balance" means, in respect of a calendar day, the Hong Kong denominated deposits held in all your savings accounts with

- (i) "Partner" means MoneySmart
- (j) "Partner Reward" means a unique redemption code that you can use to redeem a welcome gift offered by the Partner from time to time and redeemable on the Partner's platform.
- (k) "Promotion Period" means, subject to clause 10 of these terms, the period beginning on 8 April 2025 and ending on 7 July 2025 (both dates inclusive).
- (I) "Savings Requirement" has the meaning given in clause 7 of these terms.
- (m) "Savings Reward" means HKD500.
- (n) "Second Spending Requirement" has the meaning given in clause 6(b)(ii)
