

MOXRENTFS Deposits Welcome Offer Promotion (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
5. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Mox Account;
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have ‘completed’ the Mox Account opening process once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your “**Joining Day**”));
 - (c) during the period beginning on and from your Joining Day and the following 7 days (“**Fund-in Period**”), deposit at least HKD100,000 into your savings accounts with Mox; and

MOXRENTFS 存款迎新推廣 (「本推廣」) 條款及細則

1. 本條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」) 進行的本推廣。參與本推廣即表示您同意本條款。

The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.

21. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

22. Definitions

The following capitalised terms have the meanings set out below:

(a) **"60-day Hold Fund Period"** has the meaning given in clause 5(d) of these terms.

(b) **"Fund-in Period"** has the meaning given in clause 5(c) of these terms.

(c) **"HKD Savings Account Balance"** means, in respect of a day, the Hong Kong denominated deposits held in all your savings accounts with Mox, excluding all 'cash on hold' in your Mox Invest Account, as at 23:59:59 (Hong Kong time) on that day.

For the avoidance of doubt, any deposits held in your Time Deposit Account(s) will not count towards your HKD Savings Account Balance.

(d) **"Invitation Code"** means "MOXRENTFS".

(e) **"Joining Day"** has the meaning given in clause 5(b) of these terms.

(f) **"Promotion Period"** means the period beginning on 1 June 2025 and ending on 30 June 2025 (both dates inclusive).

(g) **"Reward"** means a cash reward of HKD500.
