<ol style="list-style-type: none"> 1. These terms apply to this Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in this Promotion, you agree to these terms. 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail. 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions. 5. During the Promotion Period, if: <ol style="list-style-type: none"> (a) you complete an FX Transaction or an Express Remit transaction with FX and the transaction is equal to or greater than HKD \$5000 (or HKD equivalent) "Eligible Currency Exchange Transaction" subject to these terms, you will receive a Mox Scratch Card (described below), each time <i>all</i> the requirements in this clause 5 are satisfied, up to 3 times. 6. A "Mox Scratch Card" is a digital scratch card, that is delivered via the Mox app, which you can 'scratch' to redeem a single cash reward ranging from HKD8 to HKD288 (a "Scratch Card Reward").
