

Mox Zone Referral Flash Deal promotion (the “Promotion”) terms and conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
3. Without limiting clause 2 of these terms, these terms must also be read together with The Club Membership – Mox linkage terms and conditions (“**The Club Linkage Terms**”).
4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
5. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
6. If you:
 - (a) during the Promotion Period, use a Referral Code and open a Mox Account (you will have opened a Mox Account once you receive a welcome notification from Mox);
 - (b) are invited to register for the Promotion in the Mox app and, during the Promotion Period, register for the Promotion in the Mox app (the day on which you register for the Promotion, the “**Spending Promotion Registration Day**”).
