



# Mox Asia Miles Time Deposit Promotion (July-September 2025) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- Without limiting clause 2 of these terms, these terms must also be read together with the Cathay Membership Account – Mox Registration Terms and Conditions ("Registration Terms") which can be found in the Mox app and/or our website.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 5. Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 6. If you:
  - (a) have a valid Cathay Membership Account in your name which you have registered with Mox in accordance with the Registration Terms; and
  - (b) open an Eligible Time Deposit Account during the Promotion Period,

subject to these terms, you will receive:

- (c) Asia Miles, calculated in accordance with clause 7 of these terms; and
- (d) the Upfront Interest, which we will deposit in your Mox Account,

- 9. We will display the amount of Asia Miles and Upfront Interest you may be entitled to receive prior to you opening the Eligible Time Deposit Account.
- 10. Once you have opened the Eligible Time Deposit Account, we will let AML know using your Membership Information, so that AML can deliver the relevant number of Asia Miles to your Cathay Membership Account. We are not responsible for the delivery of any Asia Miles to your Cathay Membership Account and will not be liable for any failure or delay in the delivery of your Asia Miles (or any part of it) to your Cathay Membership Account.
- 11. From time to time, we may require you to additional information provide connection with your Cathay Membership Account to maintain its registration with Mox and/or to facilitate the delivery of any Asia Miles you may be eligible to receive pursuant to the Promotion. We will notify you of any such requirements from time to

- 13. For the avoidance of doubt, other than the Asia Miles and Upfront Interest, you are not entitled to receive any additional interest or other payments in respect of any Eligible Time Deposit Account, whether during the time the relevant time deposit is held in the Eligible Time Deposit Account or upon its maturity.
- 14. If you receive any Asia Miles and the Upfront Interest and you subsequently withdraw the relevant time deposit from the Eligible Time Deposit Account before its maturity, we will deduct:
  - (a) an amount equal to the Upfront Interest deposited into your Mox Account; and
  - (b) HKD0.1 for each Asia Mile delivered to your Cathay Membership Account,

pursuant to these terms, from the principal amount of the time deposit prior to us releasing the proceeds to your Mox Account.

- 15. You will receive the reward, gift or any other benefit, or be entitled to retain the reward, gift or any other benefit received, in respect of the Promotion, only if you:

We are entitled to retain any such benefits or advantages for our own account and benefit, absolutely, without having to make any prior disclosure to you.
