



Mox Bonus Promotion (April – May 2023) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or our website) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- You can participate in the Promotion from 1
 April 2023 until 31 May 2023 (both dates
 inclusive) ("Promotion Period"). The
 Promotion Period is split into the following
 two "Challenge Periods":
 - (a) the first period which begins on 1 April 2023 and ends on 30 April 2023 (both dates inclusive); and
 - (b) the second period which begins on 1 May 2023 and ends on 31 May 2023 (both dates inclusive).

We may change the dates of the Promotion Period or a Challenge Period, and/or add subsequent Challenge Period(s), at any time in our absolute discretion.

- 5. To participate in the Promotion, you must, during a Challenge Period, complete at least one of the following:
 - (a) the "Spending Challenge" and the "Saving Challenge" (defined in clauses 6 and 7 of these terms); and/or

- 1. 本條款適用於 Mox Bank Limited (「Mox」,「我們」)進行的推 廣。參與本推廣即表示你同意接受本條 款。
- 2. 你必須一併閱讀本條款、Mox 的個人 資料收集聲明,私隱政策,一般條款及 細則(分別可於 Mox 應用程式及/或我 們的網站上找到)及我們可能向你提供 的任何其他條款。除本條款外,任何該 等條款亦一併適用,而你就我們任何產 品及服務的使用仍將受該等其他條款的 約束。本條款與我們任何其他的條款如 有任何不一致,概以本條款為準。
- 除非另有定義或另有所指,本條款中使用的定義具有我們一般條款及細則賦予的含義。
- 4. 你可於 2023 年 4 月 1 日至 2023 年 5 月 31 日參與本推廣(包括首尾兩天) (「推廣期」)。推廣期包括以下兩個「任務計算期」:

- (b) the "HKT Autopay Switch Challenge" (as defined in clause 8 of these terms); and/or
- (c) the "Goal Account Challenge" (as defined in clause 9 of these terms).
- 6. To complete the "Spending Challenge" for a Challenge Period, you must successfully make 'Eligible Card Transaction(s)' (as described below) with your Mox Card (digital or physical, spending from your Mox Account or with Mox Credit) with a total cumulative settled amount of at least 5,000 Hong Kong dollars ("HKD") during that Challenge Period.
 - "Eligible Card Transaction(s)" are transactions for the purchase of goods or services which Mox determines (in its absolute discretion) will contribute towards the Spending Challenge. Without limiting the above:
 - (a) the transaction records held by Mox will be final and conclusive in case of any discrepancy;
 - (b) transaction(s) that show as 'pending' in the Mox app (i.e. authorised but not settled by the merchant) will not be counted towards the Spending Challenge

 only those that show as 'completed' in the Mox app during the relevant
 Challenge Period will be counted; and
 - (c) some examples of transactions that are not Eligible Card Transaction(s) for the purposes of the Spending Challenge are the same as those not eligible for CashBack (see clause 8.5(b) of Schedule 1 (Terms and conditions for accounts and card management) to the General Terms and Conditions).
- 7. To complete the "Saving Challenge" during a Challenge Period, in your Savings Accounts held with Mox you must deposit and maintain New Funds which are at least equal to the greater amount of:

- (a) 10% of your Monthly Average Savings

- (b) HKD10,000.

(To avoid any doubt, if the amount calculated in clause 7(a) above is <u>more</u> than HKD 10,000 – then it is that <u>larger</u> amount that is applicable for the Saving Challenge.)

"Savings Accounts" means your Mox Account and any Goal account(s). It does not include any foreign exchange nor time deposit account(s) or balance(s).

"New Funds" means, in respect of a calendar day, any HKD Savings Account Balance held by you on that calendar day that is in excess of your Monthly Average Savings Balance for the previous calendar month.

"Monthly Average Savings Balance" means, in respect of a calendar month, the average of your HKD Savings Account Balance(s) across all calendar days in that calendar month.

"HKD Savings Account Balance" means, in respect of a calendar day, the HKD denominated deposits held in all your Savings Accounts, as at 11:59:59pm (Hong Kong time) on that calendar day. Foreign currency balances and time deposit balances do not count towards your daily total.

- 8. To complete the "HKT Autopay Switch Challenge" during a Challenge Period, you must have:
 - (a) successfully submitted your request to set up automatic payment of bills from Hong Kong Telecommunications (HKT) Limited and/or its affiliates ("HKT Group") using your Mox Card – through the 'HKT Autopay Switch' feature on the Mox app; and
 - (b) completed at least one "Eligible HKT Autopay Switch Transaction" (as

"Eligible HKT Autopay Switch

Transaction" is an automatic payment transaction of any HKT Group bill made from your Mox Card – which Mox determines (in its absolute discretion) will contribute towards the HKT Autopay Challenge. Without limiting the above:

- (a) transaction records held by Mox will be final and conclusive in case of any discrepancy;
- (b) transaction(s) that show as 'pending' in the Mox app (i.e. authorised but not settled by the merchant) will not count towards the HKT Autopay Switch Challenge – only those that show as 'completed' in the Mox app during the relevant Challenge Period will be counted; and
- (c) any transaction completed using the manual 'Pay bills' feature in the Mox app is <u>not</u> an eligible transaction for the purposes of the HKT Autopay Switch Challenge. To be eligible, the transaction must be automated via use of the 'HKT Autopay Switch' feature on the Mox app.
- To complete the "Goal Account Challenge" on any given day during a Challenge Period, you must deposit and maintain at least HKD10,000 of Goal Account New Funds across all of your Goal account(s) with Mox.
 - "Goal Account New Funds" means, in respect of a calendar day, the Goal Account Balance held by you on that calendar day that is in excess of your Goal Account Balance as of the last calendar day of the previous calendar month.
 - "Goal Account Balance" means, in respect of a calendar day, the HKD denominated deposits held in all your Goal account(s), as at 11:59:59pm (Hong Kong time) on that calendar day.
- During a Challenge Period, Mox will determine whether you have completed the

- (i) Spending Challenge and the Saving Challenge, and/or (ii) HKT Autopay Switch Challenge, and/or (iii) Goal Account Challenge, as of 23:59:59 Hong Kong time on each day of that Challenge Period. However, to receive the relevant Bonus Rate(s), completion of these challenges cannot first occur (or re-occur) on the last day of a Challenge Period.
- 11. When we determine that you have completed both the Spending Challenge and the Saving Challenge for a Challenge Period in accordance with these terms (the "Spending and Saving Challenges Completion Day"), you will receive an additional 2% p.a. HKD savings rate ("Spend and Save Bonus Rate") that will be applied on up to HKD500,000 of your total HKD denominated deposits held across all your Savings Accounts with Mox.
- 12. When we determine that you have completed the HKT Autopay Switch Challenge in accordance with these terms (the "HKT Autopay Switch Challenge Completion Day"), you will receive an additional 0.5% p.a. HKD savings rate ("HKT Autopay Switch Bonus Rate") that will be applied on up to HKD500,000 of your total HKD denominated deposits held across all your Savings Accounts with Mox.
- 13. When we determine that you have completed the Goal Account Challenge in accordance with these terms (the "Goal Account Challenge Completion Day"), you will receive an additional 0.5% p.a. HKD savings rate ("Goal Account Bonus Rate") that will be applied on up to HKD500,000 of your total HKD denominated deposits held across all your Savings Accounts with Mox.
- 14. When eligible, you will receive the Spend and Save Bonus Rate, the HKT Autopay Switch Bonus Rate, and/or the Goal Account Bonus Rate (each a "Bonus Rate") in addition to the interest rate you would ordinarily receive without participating in the Promotion ("Base Rate").
- 15. Interest at a Bonus Rate will be calculated on a 365-day year basis, based on your eligible

- 11. 當我們判斷你已完成本條款所述的相應 任務計算期的消費任務及儲蓄任務 (「消費及儲蓄任務完成日」),你可 於 Mox 所有活期存款戶口內總計港幣 500,000 元或以下的港元存款額外賺取 2%港元活期存款年利率(「消費及儲 蓄任務額外利率」)計算所得的利息。
- 12. 當我們判斷你已完成本條款所述的 HKT 轉賬易任務(「HKT 轉賬易任務 完成日」),你可於 Mox 所有活期存 款戶口內總計港幣 500,000 元或以下 的港元存款額外賺取 0.5%港元活期存 款年利率(「HKT 轉賬易任務額外利 率」)計算所得的利息。





HKD denominated deposits held in your Savings Accounts with Mox as at 23:59:59 Hong Kong time on the day after the Spending and Saving Challenges Completion Day, the HKT Autopay Switch Challenge Completion Day and/or the Goal Account Challenge Completion Day (as applicable) (each a "Completion Day").

- 16. Interest earned at a Bonus Rate for a particular day will be credited by us to your Savings Account(s) with Mox two days after the relevant Completion Day, and if you remain eligible will continue to be so credited until one day after the last day of the relevant Challenge Period. Interest earned at a Bonus Rate will be credited by us to your Savings Account(s) with Mox together with the interest earned at the Base Rate.
- 17. Once we determine you have completed the Spending Challenge during a Challenge Period, it will be complete for the remainder of that Challenge Period. However, once we determine that you have completed any of the Saving Challenge, the HKT Autopay Switch Challenge and/or the Goal Account Challenge (as applicable) during a Challenge Period, you must continually complete these challenges on each successive day in order to continue receiving the relevant Bonus Rate for the remainder of that Challenge Period.
- 18. Bonus Rate interest is payable on HKD denominated Savings Account balances from the day following a Completion Day.

 Therefore, you will not receive the relevant Bonus Rate if the Completion Day first occurs (or re-occurs) on the last day of a Challenge Period. For each Challenge Period, the last day we will credit any Bonus Rate interest to your Savings Account(s) is one day after the last day of that Challenge Period.
- 19. You must not do any of the following things before we credit interest at a Bonus Rate to any of your account(s) with Mox:
 - (a) terminate your relationship with us;

- (b) cause any account you have with us to be in arrears, suspension or default; or
- (c) any other act as we may specify from time to time.
- 20. We reserve the right, at any time, without notice or reason and in our sole discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in these terms or any reward, gift or other benefit in respect of the Promotion and its monetary value);
 - (b) suspend or terminate the Promotion or these terms:
 - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion for any reason we deem relevant; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion).

Any such decision shall be conclusive and binding on you.

- 21. If any dispute arises in connection with the Promotion, Mox's decision is final.
- 22. You can only participate in the Promotion once.
- 23. Neither your participation in the Promotion nor your eligibility to receive any reward, gift or other benefit in respect of the Promotion may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 24. To the extent permitted by laws and regulations:
 - (a) Mox and its affiliates and shareholders shall not be responsible for any loss suffered by you; and

 - (b) 暫停或終止本推廣或本條款;
 - (c) 以我們認為適當的任何理由, 拒絕 向你發放本推廣中的任何獎賞、禮 品或其他利益; 及
 - (d) 作出與本推廣相關的任何決定(包 括拒絕或暫停你參與本推廣,或決





(b) you shall release Mox and its affiliates and shareholders from all actions, proceedings and claims which may be brought against Mox or its affiliates or shareholders,

arising from or in connection with your participation in the Promotion (including any decision not to offer or pay you interest at a Bonus Rate) or these terms, unless any such loss, action, proceeding or claim is due to Mox's or its affiliates' or shareholders' negligence, fraud or wilful default and only to the extent such loss, action, proceeding or claim is reasonably foreseeable and has arisen directly and solely from such negligence, fraud or wilful default.

This clause 24 continues after the termination of these terms or the expiry of the Promotion.

- 25. The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 26. A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of their provisions under the Contracts (Rights of Third Parties) Ordinance (Cap. 623) other than as set out in these terms.
- 27. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 28. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.
- 29. To borrow or not to borrow? Borrow only if you can repay!
