



Mox New Funds Promotion (March 2024) (the "Promotion") Terms and Conditions

- 1 These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3 Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 4 You can participate in the Promotion if you:
 - (a) hold a valid Mox Account in your name;
 - (b) have not enrolled in the 'Mox New Funds Promotion (November 2023)', 'Mox New Funds Promotion (November 2023) Phase 2', 'Mox New Funds Promotion (December 2023)', 'Mox New Funds Promotion (December 2023) Phase 2', 'Mox New Funds Promotion (January 2024)', 'Mox New Funds Promotion (January 2024) Phase 2' or 'Mox New Funds Promotion (February 2024); and
 - (c) during the Registration Period, enrol in the Promotion on the Mox app by:
 - (i) depositing Mox New Funds of at least your Selected Mox New Funds Amount; and
 - (ii) selecting the amount of Mox New Funds to maintain during the Hold

Mox 新資金推廣 (2024 年 3 月) (「本推 廣」) 條款及細則

- 1 以下條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」)所提供的本推 廣。參與本推廣即表示你同意接受本條 款。
- 2 你必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策聲明、一般條款及細則(分別可於 Mox 應用程式及/或我們的網站找到)及我們可能向你提供的任何其他條款,而該等條款繼續適用於你與我們的關係及你就我們任何產品及服務的使用。如本條款與我們任何其他的條款有任何不一致,概以本條款為準。
- 3 除非另有定義或另有所指,本條款中使用的定義與我們一般條款及細則的定義含義相同。
- 4 要參與本推廣, 你必須:
 - (a) 以你的名義持有有效的 Mox 戶口;

5 If you maintain at least the amount of your Selected Mox New Funds Amount on each calendar day during the Hold Fund Period, subject to these terms, you will receive the New Funds Reward set out in the Rewards Table that corresponds to your Selected Mox New Funds Amount, which we will deposit into your Mox Account on or before 31 August 2024.

For the avoidance of doubt, if, at any point during the Hold Fund Period, the amount of Mox New Funds falls below your Selected Mox New Funds Amount, you will not receive the respective New Funds Reward.

- 6 You can only participate in the Promotion once. You can only receive one New Funds Reward pursuant to the Promotion.
- 7 You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
 - (a) you hold a valid Mox Account in your name when we attempt to give you the reward, gift or other benefit, with that Mox Account not having been suspended or closed by you or us or in arrears or default; and
 - (b) you satisfy any additional requirements we may specify from time to time.
- 8 We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in these terms or any reward, gift or other benefit in respect of the Promotion and/or its monetary value);
 - (b) suspend or terminate the Promotion or these terms;

- (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion).

Any such decision shall be conclusive and binding on you.

- 9 If any dispute arises in connection with the Promotion, our decision is final.
- 10 To the extent permitted by laws and regulations:
 - (a) Mox and its affiliates and shareholders shall not be responsible for any loss or damages suffered by you; and
 - (b) you shall release Mox and its affiliates and shareholders from all actions, proceedings and claims which may be brought against Mox or its affiliates or shareholders.

- 12 You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) and other benefits or advantages from us directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any Benefit may vary at any time and such third parties are entitled to retain any such benefit or advantages for its own account and benefit absolutely without having to make any prior disclosure to you.
- 13 The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 14 Neither your participation in the Promotion nor your eligibility to receive any reward, gift or other benefit in respect of the Promotion may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 15 Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 16 A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of the provisions under the Contracts

- 17 These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 18 The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

19 Definitions

The following capitalised terms have the meanings set out below:

- (a) "HKD Eligible Account Balance" means, in respect of a calendar day, the Hong Kong dollar denominated deposits held in all your savings accounts with Mox, excluding any deposits in your Time Deposit Accounts, as of 11:59:59 pm (Hong Kong time) on that calendar day.
- (b) "**Hold Fund Period**" means the period beginning on 1 April 2024 and ending on 15 July 2024 (both dates inclusive).
- (c) "Mox New Funds" means, in respect of a calendar day, the HKD Eligible Account Balance held by you on that calendar day that is in excess of the Reference Balance.
- (d) "New Funds Reward" means each of the cash rewards set out in the Rewards Table.
- (e) "Reference Balance" means the Hong Kong dollar denominated deposits held in all your accounts with Mox, including any deposit in your Time Deposit Accounts, as of 11:59:59 pm (Hong
