

**Mox referral surprise & delight scratch card promotion (“Promotion”) terms and conditions**

1. These terms apply to this Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in this Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
5. During the Promotion Period, if:
  - (a) you provide your Referral Code to an individual who has never held a Mox Account (a “**Referee**”);
  - (b) the Referee:
    - (i) uses your Referral Code to open a Mox Account; and
    - (ii) during the period beginning on and from the day they use your Referral Code and the following 15 days, completes their Mox Account opening process and receives a welcome notification from Mox; and
  - (c) the Referee makes an Eligible Referral Transaction,

**Mox 推薦好友驚喜即刮推廣（「本推廣」）條款及細則**

1. 本條款適用於由 Mox Bank Limited（「**Mox**」或「**我們**」）進行的本推廣。參與本推廣即表示您同意本條款。
2. 您必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策聲明、一般條款及細則（包括其所有附表），其分別可於 Mox app 及/或我們的網站找到，及我們可能向您提供的任何其他條款，而該等條款將繼續一併適用於您與我們的關係及您就我們的產品及服務的使用。
3. 如本條款與我們任何其他的條款有任何不一致，概以本條款為準。

<p>subject to these terms, you will receive a Mox Scratch Card (described below), each time <i>all</i> the requirements in this clause 5 are satisfied, up to 3 times.</p> <p>For the avoidance of doubt, you will only receive a Mox Scratch Card for the first Eligible Referral Transaction made by a Referee. You will not receive a Mox Scratch Card for the second or third Eligible Referral Transaction made by the same Referee.</p> <p>6. A “<b>Mox Scratch Card</b>” is a digital scratch card, that is delivered via the Mox app, which you can ‘scratch’ to redeem a single cash reward ranging from HKD28 to HKD288 (a “<b>Scratch Card Reward</b>”). The amount of the Scratch Card Reward will be allocated randomly. You can ‘scratch’ your Mox Scratch Card by tapping the Mox Scratch Card in your Mox app, upon which, your Scratch Card Reward will be automatically deposited into your Mox Account. You must ‘scratch’ each Mox Scratch Card on or before 18 February 2026, otherwise you will forfeit your right to the relevant Scratch Card Reward.</p> <p>7. You can only participate in this Promotion once. You can receive up to 3 Mox Scratch Cards pursuant to this Promotion.</p> <p>8. The delivery of Mox Scratch Cards is subject to a quota of 5,000 Mox Scratch Cards. We will deliver the Mox Scratch Cards on a first come, first served basis (as determined by us in our sole and absolute discretion). The ‘Promotion Period’ will end on the earlier of (a) the last day of that period and (b) the day on which we have delivered 5,000 Mox Scratch Cards. We will not update you on the quota usage or its continued availability.</p> <p>9.
