



Mox Targeted Savings Promotion (January 2025) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you
 - (a) are invited to register for the Promotion in the Mox app (we reserve the right to select and invite customers to participate in the Promotion in our sole and absolute discretion);
 - (b) during the Promotion Period, register for the Promotion in the Mox app (the day on which you register for the Promotion is your "Registration Day");
 - (c) during the period beginning on and from your Registration Day and the following 7 days ("Fund-in Period"), deposit at least the Required Promotion Amount into your savings accounts with Mox; and
 - (d) during the period beginning on the last day of the Fund-in Period and the following 59 days ("60-day Hold Fund

Mox 特定存款推廣 (2025 年 1 月) (「本推 廣」) 條款及細則

- 1. 本條款適用於由 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。參與本推廣即表示您同意本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料收集聲明、私隱政策聲明、一般條款及細則(包括其所有附表),其分別可於Mox 應用程式及/或我們的網站找到,及我們可能向您提供的任何其他條款,而該等條款將繼續一併適用於您與我們的關係及您就我們的產品及服務的使用。
- 3. 如本條款與我們任何其他的條款有任何不一致,概以本條款為準。
- 4. 除非另有定義或另有所指,本條款中使用的定義與我們一般條款及細則的定義含義相同。
- 5. 如果您
 - (a) 於 Mox 應用程式獲邀參加本推廣 (我 們保留全權酌情決定權選擇及邀請客 戶參與本推廣);
 - (b) 於推廣期內,以 Mox 應用程式註冊本 推廣 (您註冊本推廣當日為「**註冊 日**」);
 - (c) 在註冊日開始及後的 7 日内 (「**資金 存入期**」), 於您的 Mox活期存款戶口存入不少於推廣存款金額要求;及
 - (d) 於資金存入期的最後一天為首,之後 計算 59 曆日(包括首尾兩日) (「**60 日資金計算期**」),您的

subject to these terms, you will receive the Cash Reward, which we will deposit into your Mox Account on or before 16 May 2025.

- 6. For example, if your Registration Day is 21 February 2025, then:
 - (a) you must deposit at least the Required Promotion Amount into your savings accounts with Mox by 28 February 2025;
 and
 - (b) you must maintain a HKD Savings Account Balance of at least the Required Promotion Amount in your savings accounts with Mox from 28 February 2025 until 28 April 2025.
- 7. For the avoidance of doubt:
 - (a) if, at any point during the 60-day Hold Fund Period, your HKD Savings Account Balance falls below the Required Promotion Amount, you will not receive the Cash Reward; and
 - (b) any deposits held in your Time Deposit Account(s) will not count towards your HKD Savings Account Balance.
- 8. You can only participate in the Promotion once. You can only receive one Cash Reward pursuant to the Promotion.
- 9. You will receive the reward, gift or any other benefit in respect of the Promotion, only if:
 - (a) you hold a valid Mox Account in your name when we attempt to give you the reward, gift or other benefit, with that Mox Account not having been suspended or closed by you or us or in arrears or default; and

- 10. We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
 - (a) change or modify the Promotion or these terms (including any dates set out in these terms, or any reward, gift or other benefit in respect of the Promotion and/or its monetary value);
 - (b) suspend or terminate the Promotion or these terms;
 - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
 - (i) if we believe that any part of the balances in your accounts with Mox are the proceeds of any illegal, fraudulent or abnormal activity; or
 - (ii) for any other reason we deem appropriate; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

- 11. Without limiting anything in these terms, we may determine whether or not you can combine the Promotion with other offers or promotions that we may offer from time to time. We will let you know if you can combine the Promotion with other offers or promotions in the Mox app and/or our website or through any other communication channels we may determine from time to time.
- 12. If any dispute arises in connection with the Promotion, our decision is final.

 - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and
 - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox or its affiliates, shareholders or partners.

arising from or in connection with your participation in the Promotion (including any decision not to give you, or your failure to receive any reward, gift or other benefit) or these terms, unless:

- (y) any such loss, damages, action, proceeding or claim is due to; and
- (z) where such loss, damages, action, proceeding or claim was reasonably foreseeable and has arisen directly and solely from,

Mox's or its affiliates', shareholders' or partners' negligence, fraud or wilful default.

This clause 13 continues after the expiry or termination of the Promotion or these terms.

- 14. You acknowledge that third parties (including our direct or indirect shareholders) may provide us with payments (such as subsidies) or other benefits or advantages in connection with the Promotion. The nature, amount and method of calculating any such benefit or advantage may vary from time to time. We are entitled to retain any such benefit or advantage for our own account and benefit, absolutely, without having to make any prior disclosure to you.
- 15. You acknowledge that third parties may receive payments (such as remuneration,

- 18. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 19. A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.
- 20. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 21. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

22. Definitions

The following capitalised terms have the meanings set out below:

22. 定義

以下定義具有以下含義:

(a) 「**60 日資金計算期**」具有本條款第 5(d)條賦予的含義。





- (a) "60-day Hold Fund Period" has the meaning given in clause 5(d) of these terms.
- (b) "Cash Reward" means the cash reward as displayed in your Mox app at the time you register for the Promotion.
- (c) "Fund-in Period" has the meaning given in clause 5(c) of these terms.
- (d) "HKD Savings Account Balance" means, in respect of a day, the Hong Kong denominated deposits held in all your savings accounts with Mox, excluding all 'cash on hold' in your Mox Invest Account originating from unsettled proceeds from the sale of funds or securities, as at 23:59:59 (Hong Kong time) on that day.

For the avoidance of doubt, any deposits held in your Time Deposit Account(s) will not count towards your HKD Savings Account Balance.

- (e) "Promotion Period" means the period beginning on 20 January 2025 and ending on 21 February 2025 (both dates inclusive).
- (f) "Registration Day" has the meaning given in clause 5(b) of these terms.
- (g) "Required Promotion Amount" means the amount of HKD Savings Account Balance required to be maintained for the Promotion, as displayed in your Mox app at the time you register for the Promotion.
