



"MOXZEROFX" Invitation Code Promotion (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- Without limiting clause 2 of these terms, these terms must also be read together with the CX Registration Terms which can be found in the Mox app and/or our website.
- 4. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 5. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 6. If you:
 - (a) during the Promotion Period, use the Invitation Code to open a Mox Account;
 - (b) during the period beginning on and from the day you use the Invitation Code and the following 15 days, complete the Mox Account opening process (you will have 'completed' the Mox Account opening process once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your "Joining Day"));

- (e) register your Cathay Membership Account with Mox in accordance with the CX Registration Terms within 60 days from the date you have satisfied the Spending Requirement,

subject to these terms, you will receive the Reward, which will be delivered to your Cathay Membership Account on or before 1 June 2025.

- 7. Once you have satisfied all requirements in clause 6 of these terms, we will let AML know using your Membership Information, so that AML can deliver the Asia Miles to your Cathay Membership Account. We are not responsible for the delivery of any Asia Miles to your Cathay Membership Account and will not be liable for any failure or delay in the delivery of any Asia Miles (or any part thereof) to your Cathay Membership Account.
