



### Mox New Funds Promotion (February 2024) (the “Promotion”) Terms and Conditions

- 1 These terms apply to the Promotion offered by Mox Bank Limited (“Mox”, “we”, “us” or “our”). By participating in the Promotion, you agree to these terms.
- 2 You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3 Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 4 You can participate in the Promotion if you:
  - (a) hold a valid Mox Account in your name;
  - (b) have not enrolled in the ‘Mox New Funds Promotion (November 2023)’, ‘Mox New Funds Promotion (November 2023) – Phase 2’, ‘Mox New Funds Promotion (December 2023)’, ‘Mox New Funds Promotion (December 2023) – Phase 2’, ‘Mox New Funds Promotion (January 2024)’ or ‘Mox New Funds Promotion (January 2024) – Phase 2’; and
  - (c) during the Registration Period, enrol in the Promotion on the Mox app by:
    - (i) depositing Mox New Funds of at least your Selected Mox New Funds Amount; and
    - (ii) selecting the amount of Mox New Funds to maintain during the Hold Fund Period (your “**Selected Mox New Funds Amount**”).

### Mox 新資金推廣 (2024 年 2 月) (「本推廣」) 條款及細則

- 1 以下條款適用於由 Mox Bank Limited (「Mox」或「我們」) 所提供的本推廣。參與本推廣即表示你同意接受本條款。
