



## Mox New Funds Promotion (November 2023) (the "Promotion") Terms and Conditions

- 1 These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3 Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 4 You can participate in the Promotion if you:
  - (a) hold a valid Mox Account in your name; and
  - (b) during the Registration Period, enrol in the Promotion on the Mox app by:
    - (i) depositing New Funds of at least your Selected New Funds Amount; and
    - (ii) selecting the amount of New Funds to maintain during the Hold Fund Period (your "Selected New Funds Amount").
- 5 If you maintain at least the amount of your Selected New Funds Amount on each calendar day during the Hold Fund Period, subject to these terms, you will receive the New Funds Reward set out in the Rewards Table that corresponds to your Selected New Funds Amount, which we will deposit

## Mox 新資金推廣 (2023 年 11 月) (「本推 廣」) 條款及細則

- 1 以下條款適用於由 Mox Bank Limited (「**Mox**」或「**我們**」)所提供的本推 廣。參與本推廣即表示你同意接受本條 款。
- 2 你必須一併閱讀本條款、Mox 的個人資料收集聲明,私隱政策聲明,一般條款及細則(分別可於 Mox 應用程式及/或我們的網站找到),及我們可能向你提供的任何其他條款,而該等條款繼續適用於你與我們的關係及你就我們任何產品及服務的使用。如本條款與我們任何其他的條款有任何不一致,概以本條款為準。

  - (b) suspend or terminate the Promotion or these terms:
  - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
    - (i) if we believe that any part of the New Funds are the proceeds of any illegal, fraudulent or abnormal activity; or
    - (i) for any other reason we deem appropriate; and

  - (b) you shall release Mox and its affiliates and shareholders from all actions, proceedings and claims which may be brought against Mox or its affiliates or shareholders,

arising from or in connection with your participation in the Promotion (including any decision not to give you, or your failure to receive any reward, gift or other benefit) or these terms, unless such loss, damages, action, proceeding or claim is due to Mox's or its affiliates' or shareholders' negligence, fraud or wilful default and only to the extent such loss, damages, action, proceeding or claim is reasonably foreseeable and has arisen directly and solely from such negligence, fraud or wilful default.

This clause 10 continues after the expiry or termination of the Promotion or these terms.

11 You acknowledge that third parties (including our direct or indirect shareholders) may provide us with payments (such as subsidies) and other benefits or advantages in connection with the Promotion. The nature, amount and method of calculating

- 17 These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.

The following capitalised terms have the meanings set out below:

- (a) "HKD Eligible Account Balance" means, in respect of a calendar day, the Hong Kong dollar denominated deposits held in all your savings accounts with Mox, excluding any deposits in your Time Deposit Accounts, as of 11:59:59 pm (Hong Kong time) on that calendar day.
- (b) "Hold Fund Period" means the period beginning on 17 November 2023 and ending on 31 March 2024 (both dates inclusive).
- (c) "New Funds" means, in respect of a calendar day, the HKD Eligible Account Balance held by you on that calendar day that is in excess of the Reference Balance.
- (d) "New Funds Reward" means each of the cash rewards set out in the Rewards Table.
- (e) "Reference Balance" means the Hong Kong dollar denominated deposits held in all your accounts with Mox, including any deposit in your Time Deposit Accounts, as of 11:59:59 pm (Hong Kong time) on 31 October 2023, as specified in your Mox app.
- (f) "Registration Period" means the period beginning on 8 November 2023 and ending on 16 November 2023 (both dates inclusive).
- (g) "Rewards Table" means the following table in respect of the amount of New Funds and the New Funds Rewards:
