



Mox New Funds Promotion (September 2023) (Phase 2) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 4. You can participate in the Promotion if you:
 - (a) hold a valid Mox Account in your name; and
 - (b) have received an email directly from Mox inviting you to participate in the Promotion (we reserve the right to select and invite customers to participate in the Promotion in our sole and absolute discretion).
- 5. If you maintain at least the amount of New Funds set out in the Rewards Table on each calendar day during the Hold Fund Period, subject to these terms, you will receive the New Funds Reward set out in the Rewards Table that corresponds to the amount of New Funds that you have maintained, which we will deposit into your Mox Account on or before 28 February 2024.

For the avoidance of doubt, if, at any point during the Hold Fund Period, the amount of the New Funds falls below the relevant amount set out in the Rewards Table, you

- 1. 本條款適用於 Mox Bank Limited (「**Mox**」或「**我們**」)進行的推廣。 參與本推廣即表示你同意接受本條款。

 - (i) if we believe that any part of the New Funds are the proceeds of any illegal, fraudulent or abnormal activity; or
 - (ii) for any other reason we deem appropriate; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion).

 - (b) you shall release Mox and its affiliates and shareholders from all actions, proceedings and claims which may be brought against Mox or its affiliates or shareholders.

16. Definitions

The following capitalised terms have the meanings set out below:

- (a) "HKD Account Balance" means, in respect of a calendar day, the Hong Kong dollar denominated deposits held in all your accounts with Mox as of 11:59:59 pm (Hong Kong time) on that calendar day.
- (b) "HKD Savings Account Balance" means, in respect of a calendar day, the Hong Kong dollar denominated deposits held in your savings accounts with Mox as of 11:59:59 pm (Hong Kong time) on that calendar day. For the avoidance of doubt, any deposits held in your Time Deposit Accounts with Mox will not count towards your HKD Savings Account Balance.
- (c) "Hold Fund Period" means the period beginning on 30 September 2023 and ending on 31 January 2024 (both dates inclusive).
- (d) "New Funds" means, in respect of a calendar day, any HKD Savings Account Balance held by you on that calendar day that is in excess of your HKD Account Balance on 3 September 2023.
