



# Savings Base Rate Enhancement Scheme (the "Scheme") Terms and Conditions

- These terms apply to the Scheme offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Scheme, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto) (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3. Unless defined in these terms or the context requires otherwise, capitalised words have the meanings given to them in our General Terms and Conditions.
- 4. You will receive additional daily interest on up to HKD3,000,000 of your Hong Kong dollar denominated deposits held across all your savings accounts with Mox calculated at the Enhanced Savings Rate ("Additional Interest"), if (and subject to these terms) during a Completion Period, you:
  - (a) Complete through Mox one or more of the following transactions:
    - (i) buy or sell Hong Kong stock(s) or buy or sell U.S. stock(s) (a "Stock Transaction");
    - (ii) net purchase of fund unit(s) (a "Net Fund Transaction"); and
    - (iii) exchange currency(ies) to another currency(ies) (an "FX Transaction"); and
  - (b) those transaction(s) have Transaction Amounts that total (the "Cumulative

# 基本活期存款年利率升級計劃 (「本計 劃」) 條款及細則

- 1. 本條款適用於 Mox Bank Limited (「**Mox**」或「**我們**」)提供的本計 劃。參與本計劃即表示你同意接受本條 款。
- 2. 你必須一併閱讀本條款、Mox 的個人資料收集聲明,私隱政策聲明,一般條款及細則(包括其附表)(分別可於 Mox 應用程式及/或我們的網站上找到)及我們可能向你提供的任何其他條款。除本條款外,任何前述條款亦繼續一併適用於你與我們的關係及你就我們的產品及服務的使用。本條款與我們任何其他的條款如有任何不一致,概以本條款為進。

The above is referred to as the "Enhanced Savings Rate Requirement".

For the avoidance of doubt, you will not receive any Additional Interest for deposits held in your Time Deposit Account(s).

# 5. The "Transaction Amount":

(a) for a Stock Transaction is the executed 'order amount' in Hong Kong dollars (or as converted to Hong Kong dollars based on the exchange rate on the execution day), excluding any applicable fees and charges.

Without limiting the above:

- (i) for any order that is placed in a Completion Period but is executed in the following Completion Period, the Transaction Amount of that Stock Transaction will only be included in the Cumulative Amount for the following Completion Period;
- (ii) for a Stock Transaction of U.S. stock(s) that is executed between 00:00:00 05:00:00 Hong Kong time on the first calendar day of the Completion Period, the Transaction Amount will be included in the Cumulative Amount of that Completion Period; and
- (iii) the value of any stocks acquired or disposed of pursuant to any corporate action(s) will not be included in the calculation of the Cumulative Amount:
- (b) for a Net Fund Transaction is the total executed 'investment amount' in Hong Kong dollars in respect of all purchases of fund unit(s) (or as converted to Hong Kong dollars based on the exchange rate that we determine as applicable) minus the total amount in Hong Kong

(c) for an FX Transaction is the amount of currency that is sold (inclusive of any applicable fees and charges) in Hong Kong dollars (or as converted to Hong Kong dollars based on the exchange rate on the day of Completing the FX Transaction).

Without limiting the above, for an FX Transaction that is made in a Completion Period and Completed in the following Completion Period, the Transaction Amount for that FX Transaction will only be included in the Cumulative Amount for the following Completion Period.

6. We will determine whether you have met the Enhanced Savings Rate Requirement as of 23:59:59 Hong Kong time on each calendar day of a Completion Period (but excluding the last calendar day). If we determine that you have met the Enhanced Savings Rate Requirement on a calendar day of a Completion Period (excluding the last calendar day) ("Completion Day"), the Enhanced Savings Rate will be applied on up to HKD3,000,000 of your Hong Kong dollar denominated deposits held across all your savings accounts with Mox as at 23:59:59 Hong Kong time on the day following the Completion Day. If we determine you have met the Enhanced Savings Rate Requirement on a calendar day for a Completion Period (excluding the last calendar day), you must re-meet the Enhanced Savings Rate Requirement in any later Completion Period to receive Additional Interest for that later Completion Period. For clarity, it is not possible to meet the Enhanced Savings Rate Requirement on the last calendar day of a Completion Period.
- 8. Additional Interest will be calculated on a 365-day year basis. We will credit any Additional Interest to one of your savings account with Mox two calendar days after the Completion Day together with the interest that you would have received at the base rate if you had not met the Enhanced Savings Rate Requirement. If you continue to meet the Enhanced Savings Rate Requirement during a Completion Period (i.e. until the day prior to the last day of the Completion Period), we will continue to credit the Additional Interest until one day after the last day of the relevant Completion Period.
- 9. You will only receive the Additional Interest in respect of the Enhanced Savings Rate Requirement if:
  - (a) you hold a valid Mox Account in your name when we attempt to credit the Additional Interest; and
  - (b) none of your accounts with Mox have been suspended or closed by you or us or are in arrears or default.
- 10. We reserve the right, at any time, without notice or reason and in our sole and absolute discretion, to:
  - (a) change or modify the Scheme or these terms (including changing any dates set out in these terms, any applicable

- (d) make any decision in connection with the Scheme (including to refuse or suspend your participation in the Scheme or determine whether the Scheme can or cannot be combined with any other scheme).

Any such decision shall be conclusive and binding on you.

- 11. If any dispute arises in connection with the Scheme, our decision is final.
- 12. To the extent permitted by laws and regulations:
  - (a) neither Mox nor its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and
  - (b) you shall release Mox, its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox,

This clause 12 continues after the expiration or termination of these terms or the Scheme.

- 13. You acknowledge that third parties (including our direct or indirect shareholders) may provide us with payments (such as subsidies) and other benefits or advantages in connection with the Scheme. The nature, amount and method of calculating any such benefits or advantages may vary from time to time. We are entitled to retain any such benefits or advantages for our own account and benefit, absolutely, without having to make any prior disclosure to you.
- 14. You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) and other benefits or advantages from us directly or indirectly in connection with the Scheme. The nature, amount and method of calculating any such benefits or advantages may vary from time to time and such third parties are entitled to retain any such benefits or advantages for its own account and benefit, absolutely, without having to make any prior disclosure to you.

- 16. Nothing in these terms or the Scheme will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 17. A person who is not a party to these terms has no rights to enforce or enjoy the benefit of any of their provisions under the Contracts (Rights of Third Parties)
  Ordinance (Cap. 623) other than as set out in these terms.
- 18. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 19. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

## 20. Definitions

The following capitalised terms have the meanings set out below:

- (a) "Additional Interest" has the meaning given to it in clause 4 of these terms.
- (b) "Enhanced Savings Rate" means the Hong Kong dollars savings rate of 1.5% p.a.
- (c) "Enhanced Savings Rate
  Requirement" has the meaning given
  to it in clause 4 of these terms.

- (g) "Cumulative Amount" has the meaning given to it in clause 4 of these terms.
- (h) "FX Transaction" has the meaning given to it in clause 4 of these terms.
- (i) "Net Fund Transaction" has the meaning given to it in clause 4 of these terms.
- (j) "Scheme Period" means the period beginning on 1 February 2024 and until further notice from Mox.
- (k) "Stock Transaction" has the meaning given to it in clause 4 of these terms.
- (I) "Transaction Amount" has the meaning given it in clause 5 of these terms.
