

## 「日日搭·隨時飛」印花任務條款及細則

1. 「日日搭·隨時飛」印花任務(「本活動」)日期為 2025 年 7 月 21 日至 2025 年 8 月 24 日(包括首尾兩日)(「推廣期」)。
2. 印花僅限於獲發給以信用卡付款並完成的行程。
3. 額外印花只限獲發於在 TADA app 內於「付款方式」直接新增 Mox 信用卡資料的客戶，並以 Mox 信用卡付款並完成的行程，以 Google Pay 及 Apply Pay 內的 Mox 信用卡付款將不符合此資格。
