



Targeted Bill Payment Campaign (June 19th 2025 – 31st December 2025)(the "promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. If you:
 - a) are invited to register for the Promotion in the Mox app (we reserve the right to select and invite customers to participate in the Promotion in our sole and absolute discretion)
 - b) during the **Bill Payment Promotion Registration Period**, register for the Promotion in the Mox app (the "Bill Payment Promotion Registration Day"); and
 - c) complete the requirements set out in clause 6 of these terms.

- You can only participate in the Promotion once. You can only receive one of each Bill Payment Reward.
- 10. Registration for the Promotion is subject to a quota of 3,000 registrations. The 'Bill Payment Promotion Registration Period' will end on the earlier of: (a) the last day of that period, and (b) the day on which there has been 3,000 registrations. Registration for the Promotion is on a first come, first served basis (as determined by us in our absolute discretion). We will not update you on the quota usage or its continued availability.
- 11. We will determine whether an Eligible Bill Payment has occurred based on transaction records held by us (which are final and conclusive in case of any discrepancy).

- 26. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 27. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

 - (i) Each bill payment must be made to a different merchant

For the avoidance of doubt, any payment of a bill made *not* using the 'Pay bills' feature or which is *not* a 'Merchant Payment' via FPS in the Mox app (for example, through an direct debit arrangement etc.) are not 'Eligible Bill Payments'.

- f) "1-5th Bill Payment Reward" has the meaning given in clause 6 of these terms.
- g) "6th Bill Payment Reward" has the meaning given in clause 6 of these terms.
