



The Club Membership – Mox Card linkage terms and conditions

- In order to participate in certain offers and promotions that we may make available from time to time, you may be required to link your The Club Membership with your Mox Card. By applying to enroll for a new The Club Membership via the Mox app and/or linking your The Club Membership with your Mox Card, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services.
- 3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 4. Unless defined in these terms or the context requires otherwise, capitalised terms have the meanings given to them in our General Terms and Conditions.
- 5. You can apply to link your The Club Membership with your Mox Card by following the steps in the Mox app.
- 6. If you do not have a The Club Membership registered under your HKID number held in our records, you can apply to enroll for a new The Club Membership via the Mox app by following the steps in the Mox app. If you successfully apply to enroll for a The Club Membership via the Mox app, your The Club Membership will be linked with your Mox Card automatically.
- 7. You acknowledge, agree and consent to the collection, use, processing, disclosure, exchange and transfer from time to time of data (including personal data) belonging and/or relating to you as a member of The

- 1. 為參與我們可能不時提供的某些優惠或推 廣,您可能需要連結您的 The Club 會籍至 您的 Mox Card。經 Mox app 申請新的 The Club 會籍和/或連結您的 The Club 會 籍即表示您同意本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其所有附表),其分別可於 Mox app 及/或我們的網站上找到及我們可能 向您提供的任何其他條款而該等條款將繼 續一併適用於您與我們的關係及您就我們 的產品及服務的使用。

- (a) establishing and administration of the linkage of The Club Membership with your Mox Card;
- (b) enrollment and operation of The Club Membership;
- (c) where applicable, administration, operation, promotion and marketing of collaborations related to or between Mox and Club HKT; and
- (d) for any other purposes set out in The Club Privacy Statement and Mox's Privacy Statement and Personal Information Collection Statement.

Club HKT shall be solely responsible for using and handling the data collected by and/or transferred to it in accordance with its privacy policies and practices and the applicable legal and regulatory requirements. Mox shall solely be responsible for using and handling the data collected by and/or transferred to it in connection with these terms in accordance with its privacy policies and practices and applicable legal and regulatory requirements.

- 8. You acknowledge and agree that your application to enroll for a The Club Membership and/or the linkage of your The Club Membership with your Mox Card is further subject to the 'Terms and conditions of The Club', which can be found on The Club's website.
- 9. Once your The Club Membership is successfully linked with your Mox Card, if you are eligible to receive any Clubpoints from us, we will use your The Club Membership ID to facilitate the delivery of those Clubpoints directly into your The Club Membership account. Your eligibility to receive any Clubpoints shall be subject to further terms and conditions.

From time to time, we may require you to provide additional information in connection with your The Club Membership to maintain its linkage with your Mox Card and/or to facilitate the delivery of any Clubpoints you may be eligible to receive. We will notify you of any such requirements from time to time.
- 11. It is your responsibility to ensure the accuracy and completeness of the information that you provide to us. If any information that you provide to us is inaccurate and/or incomplete, we may be unable to link your The Club Membership with your Mox Card, you may not be, or no longer be, eligible to receive any Clubpoints from us and/or any Clubpoints you may be eligible to receive may not be delivered to your The Club Membership account.
- 12. If your The Club Membership is delinked from your Mox Card for whatever reason, you may become ineligible to receive Clubpoints from us.
- 13. If any dispute arises, our decision is final.
- 14. To the extent permitted by laws and regulations:
 - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damage suffered by you; and
 - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought against Mox or its affiliates, shareholders or partners.

This clause 14 continues after the expiry or termination of these terms.

- 15. You acknowledge that third parties (including our direct or indirect shareholders) may provide us with payments (such as subsidies) or other benefits or advantages in connection with these terms. The nature, amount and method of calculating any such benefit or advantage may vary from time to time. We are entitled to retain any such benefit or advantage for our own account and benefit, absolutely, without having to make any prior disclosure to you.
- 16. You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) or other benefits or advantages from us directly or indirectly in connection with these terms. The nature, amount and method of calculating any such benefit or advantage may vary from time to time and such third parties are entitled to retain any such benefit or advantage for its own account and benefit absolutely without having to make any prior disclosure to you.
- 17. Nothing in these terms constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 18. Neither the linkage of your The Club Membership with your Mox Card nor any benefit or right you may have and/or are entitled to receive under these terms may be transferred or assigned to any other person or exchanged or converted into any

- 19. Nothing under these terms will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 20. The Mox Disclaimer applies in respect of The Club, your The Club Membership and any Clubpoints you may be eligible to receive from us.
- 21. The Club, including The Club Membership and Clubpoints, are subject to terms and conditions issued by The Club.
- 22. This clause 22 is issued by Club HKT: Club HKT or its affiliates do not accept any liability, loss, damage, cost, claim whatsoever arising out of or in connection with the linkage of your The Club Membership with your Mox Card.
- 23. A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.
- 24. These terms are governed by Hong Kong law. In connection with these terms, you agree that (a) the courts of Hong Kong have exclusive jurisdiction for any proceedings you commence and (b) we may commence proceedings in any jurisdiction.
- 25. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

26. Definitions

The following capitalised terms have the meanings set out below:

- (a) "Club HKT" means Club HKT Limited.
- (b) "Clubpoints" means the loyalty points of The Club.

- 25. 本條款的英文與中文版本如有任何不一致,概以英文版本為準。

26. 定義

(a) 「**Club HKT** 」是指 Club HKT Limited。





- (c) "The Club" means the platform operated by Club HKT, which offers its members various benefits and services including redemption of Clubpoints for designated goods and services, tailored marketing and management of members. The Club is owned, operated and managed by Club HKT.
- (d) "The Club Membership" means a membership to The Club. A member of The Club will be able to receive and/or redeem various benefits offered by or through The Club subject to the 'Terms and conditions of The Club' (which can be found on The Club's website) and other relevant terms which may be announced or notified to members from time to time by different means of communication.
- (e) "The Club Privacy Statement" means Personal Information Collection Statement of Club HKT and the Club HKT Privacy Statement (which can be found on The Club's website).
