



Mox Time Deposits Telemarketing Promotion (February 2025 CNY offer) (the "Promotion") Terms and Conditions

- 1 These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3 Unless the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
- 4 To participate in the Promotion, you must have been selected by and received an invitation call directly from Mox confirming that you are eligible to participate in the Promotion ("Invitation Call"). We reserve the right, in our sole and absolute discretion, to select and invite customers and/or update your eligibility to participate in the Promotion from time to time.
- 5 If you open an Eligible Time Deposit Account within 2 calendar days immediately following the day on which you receive the Invitation Call, subject to these terms, you will receive the applicable Reward as set out in clause 6 of these terms by the end of the calendar month immediately following the date on which you open your Eligible Time Deposit Account.

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其附表)(分別可於 Mox 應用程 式及/或我們的網站上找到)及我們可能向 您提供的任何其他條款,而該等條款繼續 適用於您與我們的關係及您就我們的產品 及服務的使用。如本條款與我們任何其他 的條款有任何不一致,概以本條款為準。
- 3. 除非本條款另有所指,否則本條款中使用 的定義與我們一般條款及細則的定義含義 相同。
- 4. 要參加本推廣,您必須被 Mox 選中並收到 由 Mox 打出的邀請電話確認您符合資格參 加本推廣(「**邀請電話**」)。我們保留全 權酌情決定不時選擇及邀請客戶參加本推 廣,及/或就您參加本推廣的資格作出更 新。

- 7 You can only participate in the Promotion once. You can only receive one Reward.
- 8 You will receive the reward, gift or any other benefit, or be entitled to retain the reward, gift or any other benefit you have received, in respect of the Promotion, only if you:
 - (a) hold a valid Mox Account in your name at the time we attempt to give you the reward, gift or other benefit, with that Mox Account not having been

 - (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
 - (i) if we believe that any part of the time deposit in any Eligible Time Deposit Account are the proceeds of any illegal, fraudulent or abnormal activity; or
 - (ii) for any other reason we deem appropriate; and
 - (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

10 Without limiting anything in these terms, we may determine whether or not you can combine the Promotion with other offers or promotions that we may offer from time to time. We will let you know if you can

- (y) any such loss, damages, action, proceeding or claim is due to; and
- (z) where such loss, damages, action, proceeding or claim was reasonably foreseeable and has arisen directly and solely from,

Mox's or its affiliates', shareholders' or partners' negligence, fraud or wilful default.

This clause 12 continues after the termination of these terms.

- 18 A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.
- 19 These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special

21 Definitions

The following capitalised terms have the meanings set out below:

- (a) "Eligible Time Deposit Account" means a Time Deposit Account placed with Time Deposit New Funds with a tenor of 3 months or more and a principal amount of HKD100,000 or above.
- (b) "HKD Savings Account Balance" means the Hong Kong dollar denominated deposits held in all your savings accounts with Mox, excluding any 'cash on hold' in your Mox Invest Account originating from unsettled proceeds from the sale of funds or securities. For the avoidance of doubt, any deposits held in your Time Deposit Accounts will not count towards your HKD Savings Account Balance.
- (c) "Invitation Call" has the meaning given in clause 4 of these terms.
- (d) "Reward" has the meaning given in clause 6 of these terms.
- (e) "Time Deposit New Funds" means, as at the time you place a time deposit, the HKD Savings Account Balance held by you at that time that is in excess of your HKD Savings Account Balance as of 11:59:59pm (Hong Kong time) on the last day of the previous calendar month, excluding the principal amount of any time deposits that has matured in the current calendar month and

21. 定義

以下定義於本條款内具有以下的含義:

- (a) 「**合資格定期存款戶口**」指3個月或以 上為存款期及本金達 100,000 港元或 以上的新資金定期存款戶口。
- (b) 「港元活期存款戶口結餘」是指您於 Mox 的所有活期存款戶口所持有的港 元存款,但不包括您的 Mox Invest 戶 口中來自出售基金或股票的未結算收 益的所有「已用金額」。為免生疑 問,任何於您的定期存款戶口內的存 款將不會計入您的港元活期存款戶口 結餘。
- (c) 「**邀請電話**」具有本條款第 4 條賦予 的含義。
- (d) 「**獎賞**」具有本條款第 6 條賦予的含 義。
- (e) 「新資金定期存款」是指就您設立定期存款當時而言,您所持有,超出上一個曆月最後一天香港時間晚上 11 時59 分59 秒的港元活期存款戶口結餘,的港元活期存款戶口結餘,但不包括當歷月到期並存入您 Mox 戶口的定期存款的本金,即在您設立相關定期存款時,在 Mox 應用程式的定期存款设立頁面中顯示為您的「新資金」。
