



## Mox Time Deposits Telemarketing Promotion (March 2025) (the "Promotion") Terms and Conditions

- 1 These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- 3 Unless the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
- 4 To participate in the Promotion, you must have been selected by and received an invitation call directly from Mox confirming that you are eligible to participate in the Promotion ("Invitation Call"). We reserve the right, in our sole and absolute discretion, to select and invite customers and/or update your eligibility to participate in the Promotion from time to time.
- 5 If you open an Eligible Time Deposit Account within 2 calendar days immediately following the day on which you receive the Invitation Call, subject to these terms, you will receive the applicable Reward as set out in clause 6 of these terms by the end of the calendar month immediately following the date on

## Mox 定期存款電話推廣 (2025 年 3 月) (「本推廣」) 條款及細則

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其附表)(分別可於 Mox 應用程 式及/或我們的網站上找到)及我們可能向 您提供的任何其他條款,而該等條款繼續 適用於您與我們的關係及您就我們的產品 及服務的使用。如本條款與我們任何其他 的條款有任何不一致,概以本條款為準。
- 3. 除非本條款另有所指,否則本條款中使用 的定義與我們一般條款及細則的定義含義 相同。

- 7 For avoidance of doubt, your Eligible Time Deposit Account must:
  - (a) be placed with Time Deposit New Funds;

- (b) have a principal amount of no less than HKD250,000 if denominated in Hong Kong Dollars or USD50,000 if denominated in United States Dollars; and
- (c) have a tenor of no less than 3 months.
- 8 You can only participate in the Promotion once. You can only receive one Reward.
- 9 You will receive the reward, gift or any other benefit, or be entitled to retain the reward, gift or any other benefit you have received, in respect of the Promotion, only if you:
  - (a) hold a valid Mox Account in your name at the time we attempt to give you the reward, gift or other benefit, with that Mox Account not having been suspended or closed by you or us or in arrears or default;
  - (b) your Eligible Time Deposit Account is still valid and active when we attempt to give you the reward, gift or other benefit; and
  - (c) you satisfy any additional requirements we may specify from time to time.
- 10 We reserve the right at any time, without notice or reason and in our sole discretion. to:
  - (a) change or modify the Promotion or these terms (including any dates set out in these terms, any reward, gift or other benefit in respect of the Promotion and/or its monetary value);
  - (b) suspend or terminate the Promotion or these terms;

- (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion).

Any such decision shall be conclusive and binding on you.

- 11 Without limiting anything in these terms, we may determine whether or not you can combine the Promotion with other offers or promotions that we may offer from time to time. We will let you know if you can combine the Promotion with other offers or promotions in the Mox app and/or our website or through any other communication channels we may determine from time to time.
- 12 If any dispute arises in connection with the Promotion, our decision is final.
- 13 To the extent permitted by laws and regulations:
  - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and
  - (b) you shall release Mox and its affiliates, shareholders and partners from all actions, proceedings and claims which may be brought by or against Mox or its affiliates, shareholders or partners,

- (y) any such loss, damages, action, proceeding or claim is due to; and
- (z) where such loss, damages, action, proceeding or claim was reasonably foreseeable and has arisen directly and solely from,

Mox's or its affiliates', shareholders' or partners' negligence, fraud or wilful default.

This clause 13 continues after the termination of these terms.

- 14 You acknowledge that third parties (including direct or indirect shareholders) may provide us payments (such as subsidies) and other benefits or advantages in connection with the Promotion. The nature, amount and method of calculating any such benefits or advantages may vary from time to time. We are entitled to retain any such benefits or advantages for our own account and benefit, absolutely, without having to make any prior disclosure to you.
- 15 You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) or other benefits or advantages from us directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any such benefits or advantages may vary from time to time and such third parties are entitled to retain any such benefits or advantages for its own account and benefit, absolutely, without having to make any prior disclosure to you.

- 18 Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 19 A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.
- 20 These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 21 The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

## 22 Definitions

The following capitalised terms have the meanings set out below:

- (a) "Eligible Time Deposit Account" means a Time Deposit Account placed with Time Deposit New Funds with a tenor of 3 months or more and a principal amount of:
  - (i) in respect of an Eligible Time Deposit Account denominated in

- (b) "Savings Account Balance" means the Hong Kong dollar or United States dollar denominated deposits held in all your savings accounts with Mox, excluding any 'cash on hold' in your Mox Invest Account originating from unsettled proceeds from the sale of funds or securities. For the avoidance of doubt, any deposits held in your Time Deposit Accounts will not count towards your Savings Account Balance.
- (c) "Invitation Call" has the meaning given in clause 4 of these terms.
- (d) "Reward" has the meaning given in clause 6 of these terms.
- (e) "Time Deposit New Funds" means, as at the time you place a time deposit, the Savings Account Balance held by you at that time that is in excess of your Savings Account Balance as of 11:59:59pm (Hong Kong time) on the last day of the previous calendar month, excluding the principal amount of any time deposits that has matured in the current calendar month and deposited into your Mox Account, as displayed as your "new funds" in the time deposit set up page in your Mox app at the time you place the relevant time deposit.
