



Mox Time Deposits Telemarketing Promotion (December 2024) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
- 4. To participate in the Promotion, you must have been selected by and received an invitation call directly from Mox confirming that you are eligible to participate in the Promotion ("Invitation Call"). We reserve the right, in our sole and absolute discretion, to select and invite customers and/or update your eligibility to participate in the Promotion from time to time.
- 5. If you successfully open an Eligible Time Deposit Account within 2 calendar days from the day on which you receive our the Invitation Call, subject to these terms, you will receive the applicable Reward as set out in clause 6 by the end of the calendar month immediately following the date on which the Eligible Time Deposit Account is successfully opened.
- 6. The Reward you may be entitled to receive under this Promotion shall be calculated by reference to the principal amount and tenor

## Mox 定期存款電話推廣 (2024 年 12 月) (「本推廣」) 條款及細則

- 1. 本條款適用於 Mox Bank Limited (「Mox」或「我們」)進行的本推廣。 參與本推廣即表示您同意接受本條款。
- 2. 您必須一併閱讀本條款、Mox 的個人資料 收集聲明、私隱政策聲明、一般條款及細 則(包括其附表)(分別可於 Mox 應用程 式及/或我們的網站上找到)及我們可能向 您提供的任何其他條款,而該等條款繼續 適用於您與我們的關係及您就我們的產品 及服務的使用。如本條款與我們任何其他 的條款有任何不一致,概以本條款為準。

  - (a) neither Mox nor any of its affiliates, shareholders or partners shall be responsible for any loss or damages suffered by you; and

We are entitled to retain any such benefits or advantages for our own account and benefit, absolutely, without having to make any prior disclosure to you.

You acknowledge that third parties may receive payments (such as remuneration, commission and rebates) or other benefits or advantages from us directly or indirectly in connection with the Promotion. The nature, amount and method of calculating any such benefits or advantages may vary from time to time and such third parties are entitled to retain any such benefits or advantages for its own account and benefit, absolutely, without having to make any prior disclosure to you.

- 19. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

## 20. Definitions

The following capitalised terms have the meanings set out below:

- (a) "Eligible Time Deposit Account" means a Time Deposit Account placed with Time Deposit New Funds with a tenor of 3 months or above and a principal amount of HKD100,000 or above.
- (b) "Invitation Call" has the meaning given in clause Error! Reference source not found. of these terms.
- (c) "Reward" has the meaning given in clause 6 of these terms.
- (d) "Time Deposit New Funds" means, as at the time you place a time deposit, the HKD Savings Account Balance held by you at that time that
