

Mox Time Deposits Telemarketing Promotion (December 2024) (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**” or “**our**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy Statement, General Terms and Conditions (including the schedules thereto), each of which can be found in the Mox app and/or on our website, and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
3. Unless the context requires otherwise, capitalised terms used in these terms have the same meanings as those defined in our General Terms and Conditions.
4. To participate in the Promotion, you must have been selected by and received an invitation call directly from Mox confirming that you are eligible to participate in the Promotion (“**Invitation Call**”). We reserve the right, in our sole and absolute discretion, to select and invite customers and/or update your eligibility to participate in the Promotion from time to time.
5. If you successfully open an Eligible Time Deposit Account within 2 calendar days from the day on which you receive our the Invitation Call, subject to these terms, you will receive the applicable Reward as set out in clause 6 by the end of the calendar month immediately following the date on which the Eligible Time Deposit Account is successfully opened.
6. The Reward you may be entitled to receive under this Promotion shall be calculated by reference to the principal amount and tenor

Mox 定期存款電話推廣 (2024 年 12 月) (「本推廣」) 條款及細則

1. 本條款適用於 Mox Bank Limited (「**Mox**」或「**我們**」) 進行的本推廣。參與本推廣即表示您同意接受本條款。
