



Welcome Bonus Promotion (February – March 2023) (the “Promotion”) Terms and Conditions

1. These terms apply to the Promotion offered by Mox Bank Limited (“**Mox**”, “**we**”, “**us**”). By participating in the Promotion, you agree to these terms.
2. You must read these terms along with Mox’s Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or our website) and any other terms we may provide to you. These terms apply in addition to any such other terms, and your use of any of our products and services remains subject to such other terms.
3. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
4. You can participate in the Promotion from 1 February 2023 until 31 March 2023 (both dates inclusive) (“**Promotion Period**”). We may change the dates of the Promotion Period and other any dates set out in these terms at any time in our absolute discretion.
5. To participate in the Promotion, you must:
 - (a) download the Mox app and successfully open a Mox Account during the Promotion Period. Please note, if you apply to open a Mox Account during the Promotion Period but your application is still in-progress after the last day of the Promotion Period you can no longer participate in the Promotion; and
 - (b) not have held a Mox Account in your name at any time during the 12-month period preceding the date you are notified by Mox that your Mox Account has been successfully opened (“**Joining Date**”).

迎新 Bonus 推廣 (2023 年 2 月至 3 月) (「本推廣」) 條款及細則

1. 本條款適用於 Mox Bank Limited (「**Mox**」, 「**我們**」) 進行的推廣。參與本推廣即表示你同意接受本條款。
2. 你必須一併閱讀本條款、Mox 的個人資料收集聲明, 私隱政策, 一般條款及細則 (分別可於 Mox 應用程式及/或我們的網站上找到) 及我們可能向你提供的任何其他條款。除本條款外, 任何該等條款亦一併適用, 而你就我們任何產品及服務的使用仍將受該等其他條款的約束。
3. 本條款與我們任何其他的條款如有任何不一致, 概以本條款為準。
4. 你可於 2023 年 2 月 1 日開始至 2023 年 3 月 31 日參與本推廣, 包括首尾兩天 (「**推廣期**」)。我們保留全權酌情決定, 隨時更改推廣期的日期及本條款中訂立的任何其他日期。
5. 要參與本推廣, 你必須:

Hong Kong dollar savings rate (“Welcome Bonus Rate”), that will be applied on up to HKD500,000 of your total Hong Kong dollar denominated deposits held across all your savings accounts with Mox, for 60 days starting from (and including) the Joining Date (“Reward Period”), on top of the interest rate you would ordinarily receive without participating in the Promotion (“Base Rate”).</p> <p>7.
