



## Welcome Bonus Promotion (November 2023 – January 2024) (the "Promotion") Terms and Conditions

- These terms apply to the Promotion offered by Mox Bank Limited ("Mox", "we", "us" or "our"). By participating in the Promotion, you agree to these terms.
- 2. You must read these terms along with Mox's Personal Information Collection Statement, Privacy Policy, General Terms and Conditions (each of which can be found in the Mox app and/or on our website) and any other terms we may provide to you, which continue to apply to your relationship with us and your use of our products and services. If there is any inconsistency between these terms and any of our other terms, these terms will prevail.
- Unless defined in these terms or the context requires otherwise, capitalised terms have the same meanings given to them in our General Terms and Conditions.
- 4. To participate in the Promotion, you must:
  - (a) successfully open a Mox Account during the Promotion Period. You will have 'successfully' opened your Mox Account once you have received a welcome notification from Mox (the day on which you receive your welcome notification, your "Joining Day"); and
  - (b) during the period beginning on your Joining Day and the following 59 days ("Reward Period"), ensure that Mox is set as your 'FPS default bank' ("FPS Requirement") in the Mox app.
- 5. We will determine whether you have satisfied the FPS Requirement as of 23:59:59 Hong Kong time on each calendar day during the Reward Period, based on records held by us which will be considered final and conclusive. If we determine that you have satisfied the FPS

## 迎新 Bonus 推廣(2023 年 11 月至 2024 年 1 月)(「本推廣」)條款及細則

- 1. 本條款適用於 Mox Bank Limited (「**Mox**」或「**我們**」)進行的推廣。參 與本推廣即表示你同意接受本條款。
- 2. 你必須一併閱讀本條款、Mox 的個人資料 收集聲明,私隱政策,一般條款及細則 (分別可於 Mox 應用程式及/或我們的網 站上找到)及我們可能向你提供的任何其 他條款。除本條款外,任何前述條款亦繼 續一併適用於你與我們的關係及你就我們 任何產品及服務的使用。本條款與我們任 何其他的條款如有任何不一致,概以本條 款為準。
- 3. 除非另有定義或另有所指,本條款中使用的定義具有我們一般條款及細則賦予的含義。
- 4. 要參與本推廣, 你必須:
  - (a) 在推廣期内成功開立 Mox 戶口。當你 從 Mox 收到迎新通知,你將被視為已 成功開立 Mox 戶口(收到迎新通知當 天為「開戶日期」);及
  - (b) 於你的開戶日期及往後的 59 天(「獎 賞期」),確保於 Mox app 内 Mox 被設定為你的「轉數快」預設收款銀行 (「轉數快要求」)。
- 5. 在獎賞期內,我們將根據我們持有的記錄,於每一個曆日的香港時間 23 時 59 分59 秒決定你是否符合轉數快要求,而任何此等記錄均視為最終及具決定性。當我們判斷你於一個曆日已完成轉數快要求(該





Requirement on a particular calendar day (such calendar day, a "Completion Day"), you will receive additional interest at a savings rate of 3.2% p.a. ("Welcome Bonus Rate") on up to HKD250,000 of your total Hong Kong dollar denominated deposits held across all your savings accounts with Mox as at 23:59:59 Hong Kong time on the day following the Completion Day. You will receive the additional interest on top of the interest you would receive at the base rate without participating in the Promotion.

- 6. Interest at the Welcome Bonus Rate will be calculated on a 365-day year basis. We will credit any additional interest earned at the Welcome Bonus Rate to the relevant savings account(s) two days after the Completion Day, together with the interest earned at the base rate.
- 7. You will receive the reward, gift or other benefit in respect of the Promotion, only if:
  - (a) you have not held a Mox Account in your name at any time during the 12month period preceding your Joining Day. You are considered to have held a Mox Account even if you haven't completed any transactions on your prior Mox Account;
  - (b) you hold a valid Mox Account in your name when we attempt to give you the reward, gift or other benefit, with that Mox Account not having been suspended or closed by you or us or in arrears or default: and
  - (c) you satisfy any additional requirements we may specify from time to time.
- 8. We reserve the right, at any time, without notice or reason and in our sole discretion, to:
  - (a) change or modify the Promotion or these terms (including any dates set out in these terms or any reward, gift

- (b) suspend or terminate the Promotion or these terms:
- (c) refuse to give you any reward, gift or other benefit in respect of the Promotion:
  - (i) if we believe your Mox Account has been opened for an improper purpose (for example, to secure multiple rewards, gifts or other benefits by closing and opening one or more Mox Accounts) or any proceeds in your accounts with Mox are the proceeds of any illegal, fraudulent or abnormal activity; or
  - (ii) for any other reason we deem appropriate; and
- (d) make any decision in connection with the Promotion (including to refuse or suspend your participation in the Promotion or determine whether the Promotion can or cannot be combined with any other offer or promotion).

Any such decision shall be conclusive and binding on you.

- 9. If you've received any reward, gift or other benefit in respect of the Promotion and you subsequently close your Mox Account within 12 months of when you opened it, we have the right to deduct an amount equal to the total value of the reward, gift or other benefit from your Mox Account prior to us completing the closure of your Mox Account.
- 10. If any dispute arises in connection with the Promotion, our decision is final.
- 11. To the extent permitted by laws and regulations:
  - (a) Mox and its affiliates and shareholders shall not be

This clause 11 continues after the expiry or termination of the Promotion or these terms.

- 12. Neither your participation in the Promotion, nor your eligibility to receive any reward, gift or other benefit in respect of the Promotion may be transferred or assigned to any other person or exchanged or converted into any other benefit or right.
- 13. The Promotion does not constitute any offer, invitation or recommendation to any person to enter into any transaction.
- 14. Nothing under these terms or the Promotion will deem, imply or suggest that a person or entity is acting as our agent or representative or otherwise soliciting business on our behalf.
- 15. A person who is not a party to these terms has no right to enforce or enjoy the benefit of any of these terms pursuant to the Contracts (Rights of Third Parties) Ordinance (Cap. 623), other than as set out in these terms.

- 15. 並非本條款協議一方的人士無權按《合約 (第三者權利)條例》(香港法例第 623 章)執行本條款的任何條文,或享有本條 款的任何條文下的利益,除本條款另有列 出外。





- 16. These terms are governed in all respects by and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China. The parties submit to the exclusive jurisdiction of the courts of the Hong Kong Special Administrative Region of the People's Republic of China.
- 17. The English version prevails if there is any inconsistency between the English and Chinese versions of these terms.

## 18. **Definitions**

The following capitalised terms have the meanings set out below:

- (a) "Completion Day" has the meaning give to it in clause 5 of these terms.
- (b) "FPS" means Faster Payment System, a payment financial infrastructure operated by Hong Kong Interbank Clearing Limited.
- (c) "FPS Requirement" has the meaning given to is in clause 4(b) of these terms.
- (d) "**Joining Day**" has the meaning given to it in clause 4(a) of these terms.
- (e) "Promotion Period" means the period between 1 November 2023 and 31 January 2024 (both dates inclusive).
- (f) "Reward Period" has the meaning given to it in clause 4(b) of these terms. For example, if your Joining Day is 1 November 2023, the last day of your Reward Period is 30 December 2023.
- (g) "Welcome Bonus Rate" has the meaning given to is in clause 5 of these terms.

- (d) 「**開戶日期**」擁有本條款第4(a)條所述的定義。
- (e) 「**推廣期**」是指 2023 年 11 月 1 日至 2024 年 1 月 31 日,包括首尾兩天。
- (f) 「**獎賞期**」擁有本條款第4(b)條所述的 定義。例如,你的開戶日期是 2023 年 11月1日,獎賞期的最後一天將是 2023年12月30日。
- (g) 「**迎新額外利率**」擁有本條款第5條所 述的定義。
